A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH JEFF ENTERPRISES FOR THE PROJECT CONSTRUCTION OF MULTI-PURPOSE COVERED COURT WITH STAGE LOCATED AT MUNTINLUPA NATIONAL HIGH SCHOOL-ANNEX, SOUTHVILLE 3 BARANGAY POBLACION, MUNTINLUPA CITY IN THE AMOUNT OF ELEVEN MILLION FOUR HUNDRED FOURTEEN THOUSAND PESOS (PHP11,414,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2017 EXECUTIVE BUDGET UNDER SCHOOL BOARD FUND-CAPITAL OUTLAY.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, “*xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others*”;

WHEREAS, pursuant to Section 76 of RA. 9184 states that, “*any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly*”;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project **Construction Of Multi-Purpose Covered Court with Stage** located at **Southville 3, Barangay Poblacion, Muntinlupa City** in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City’s Website and likewise posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, lone bidder was submitted on November 8, 2017 and bid passed the preliminary examination of bid;

WHEREAS, the amount appropriated for the said project shall be taken from the 2017 Executive Budget under the School Board Fund-Capital Outlay;

WHEREAS, the *Approved Budget for the Contract (ABC)* for the project Construction Of **Multi-Purpose Covered Court with Stage** is (**Php11,418,043.98**);

WHEREAS, the project was awarded to **JEFF ENTERPRISES** who being the responsive bidder for the project, **Construction Of Multi-Purpose Covered Court with Stage** located at **Muntinlupa National High School Annex, Southville 3, Barangay Poblacion, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8TH Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **JEFF ENTERPRISES** for Muntinlupa National High School-Annex, Southville 3, Barangay Poblacion, Muntinlupa City In The Amount Of Eleven Million Four Hundred Fourteen Thousand Pesos (Php11,414,000.00) Which Amount Shall Be Taken From The 2017 Executive Budget Under School Board Fund-Capital Outlay.




