WHEREAS, Section 458 (1)(xi) of the Local Government Code of 1991 provides that, "(xi) when the finances of the city government allow, provide for additional allowances and other benefits to judges, prosecutors, xxx, and other national government officials stationed in or assigned to the city";

WHEREAS, it is the intention of the city to continue granting the monthly allowance/honorarium of the said officials;

WHEREAS, there is an available budget from the 2018 Executive Budget under the Non-Office-Allowance/Honorarium to National Government Agencies;

NOW THEREFORE, BE IT ORDAIN, AS IT IS HEREBY ORDAINED, by the 8th Sangguniang Panlungsod of Muntinlupa in session assembled that:

SECTION 1. Title - This ordinance shall be known as, "An Ordinance Granting Monthly Allowance/Honorarium to National Government Personnel stationed or assigned in the City of Muntinlupa".

SECTION 2. Coverage - Covered of this ordinance in granting the monthly allowance/honorarium to the national government offices are the following:

SECTION 4. Copies of this Ordinance shall be furnished to the Office of the *City Budget, City Treasurer, Accounting Office, City Auditor, City Prosecutor and Executive Judges of the RTC and MTC and Head of Public Attorney Office (PAO)* and other national government offices concerned for their information;

SECTION 5. Separability Clause – If for any reason or reasons any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.
