AN ORDINANCE GRANTING FRANCHISE TO MATCH POINT GAMING CENTER, INC., TO OPERATE ELECTRONIC BINGO BOUTIQUE LOCATED AT ENTRATA URBAN COMPLEX, ALONG MIDWAY SPECTRUM MIDWAY EXTENSION. BARANGAY ALABANG, MUNTINLUPA CITY THEREBY CANCELLING THE PREVIOUS GRANT UNDER ORDINANCE NO. 17-129.

WHEREAS, the Match Point Gaming Center, Inc., is a duly registered corporation with the Securities and Exchange Commission (SEC) duly authorized to "primarily furnish, provide, operate and maintain amusement and recreation facilities to the public, such as, but not limited to bingo games;

WHEREAS, the 8th Sangguninang Panlungsod of Muntinlupa enacted Ordinance No. 17-129, granting franchise to Match Point Gaming Center, Inc., to operate Electronic Bingo Boutique located at Filinvest Supermall, Barangay Alabang, Muntinlupa City;

WHEREAS, the PAGCOR wrote a letter to Mr. Mark Adrian T. Reyes, President of Match Point Gaming Center, Inc., dated January 10, 2018, on the result of their application to operate Electronic Bingo (E-BINGO) at the Ground Flooor of Festival Mall Corporate City, Barangay Alabang, Muntinlupa City, informing them that the site applied for have already an existing three(3) gaming site operators offering electronic games and/or electronic bingo games (Traditional Bingo, Electronic Bingo and Game Zone). That the application for the proposed site was found non-compliant in accordance with an approved amendments to the Regulation 3, Section 3 of the Gaming Site Regulatory Manual (GRSM) version 3.0 which only allows a maximum of three (3) co-located gaming sites inside a mall and a maximum of two (2) co-located gaming sites in an

arcade or commercial building;

WHEREAS, the operation of a gaming and amusement center falls within the jurisdiction of the Philippine Amusement and Gaming Corporation (PAGCOR). However, the local government unit where the intended center is to be established should issue a favorable endorsement through a Council approve resolution;

WHEREAS, due to the non-compliant in the location of Match Point Gaming Center, Inc., they requested to transfer and move the operation of its Electronic Bingo Boutique from Festival Supermall located at Barangay Alabang, Muntinlupa City to Entrata Urban Complex, located at Spectrum Midway Extension, Barangay Alabang, Muntinlupa City and to amend the enacted Ordinance No. 17-129 on the provision in the location of the said E-Bingo Boutique.

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 8th Sangguniang Panlungsod, Granting Franchise To Match Point Gaming Center, Inc., To Operate Electronic Bingo Boutique Located At Entrata Urban Complex, Along Spectrum Midway Extension, Barangay Alabang, Muntinlupa City, Thereby Cancelling The Prévious Grant Under Ordinance 17-129.
