AN ORDINANCE AMENDING SECTION 1(A) OF ORDINANCE NO. 09-086, ENTITLED, "AN ORDINANCE REGULATING THE OPERATION OF HEALTH SERVICES RENDERED IN THE DIFFERENT LOCAL GOVERNMENT HEALTH FACILITIES WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF MUNTINLUPA SUCH AS LABORATORY TESTS, OPERATION OF LYING-IN CENTERS AND RADIOLOGY SERVICES, AND PRESCRIBING FEES THEREFORE PURSUANT TO THE LOCAL GOVERNMENT CODE AND OTHER PERTINENT LAWS."

SECTION 1. Title. This ordinance shall be known as “an ordinance amending Section 1(A) of Ordinance No. 09-086, entitled, “An Ordinance Regulating The Operation Of Health Services Rendered In The Different Local Government Health Facilities Within The Territorial Jurisdiction Of The City Of Muntinlupa Such As Laboratory Tests, Operation Of Lying-In Centers And Radiology Services, And Prescribing Fees Therefore Pursuant To The Local Government Code And Other Pertinent Laws.”

SECTION 2. Section 1(A) of Ordinance No. 09-086 shall **now be amended** and **shall be read** as follows:

SECTION 3. Repealing Clause – All ordinances, administrative circulars and executive orders or parts thereof which are inconsistent with any part of the provisions of this Ordinance is hereby repealed or amended accordingly.

SECTION 4. Separability Clause – If, for any reason or reasons, any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 5. Effectivity Clause – this ordinance shall take effect upon its approval.


