#### ORDINANCE NO. 18-197

AN ORDINANCE GRANTING THE AMOUNT OF TEN THOUSAND PESOS (PHP10,000.00) EACH AS FINANCIAL ASSISTANCE TO THE AFFECTED EIGHTEEN (18) FARMERS LOCATED BESIDE THE MUNTINLUPA SPORTS COMPLEX, BARANGAY TUNASAN, MUNTINLUPA CITY AND SHALL BE TAKEN FROM THE SPECIAL ACTIVITIES FUND (SAF) OF THE CITY MAYOR.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that, "every local government unit shall exercise the granted, those necessarily implied therefrom, as well as power necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. ";

WHEREAS, the farmers who are affected by the development projects of the city at the Muntinlupa Sports Complex (MSC) due to the excavation/distribution of their agricultural produce, requested for financial assistance;;

WHEREAS, the City Government grant unto them Ten Thousand Pesos (Php10.000.00) each for eighteen (18) farmers for a total amount of One Hundred Eighty Thousand Pesos (Php180,000.00) and the Budget shall be taken from the Executive Budget under the City Mayor's SAF;

WHEREAS, the farmers have no objection on the amount of Ten Thousand Pesos (Php10,000.00) being offered by the city government of Muntinlupa;

NOW BE IT ORDAINED, AS IS HEREBY ORDAINED, by 8th Sangguniang Panlungsod of Muntinlupa to grant the amount of Ten Thousand Pesos (Php10,000.00) each as Financial Assistance to the affected eighteen (18) farmers located beside the Muntinlupa Sports Complex, Barangay Tunasan, Muntinlupa City and shall be taken from the Special Activities Fund (SAF) of the City Mayor.

ENACTED, by the 8th Sangguniang Panlungsod of Muntinlupa, this 10th day of September 2018, on its 88th Regular Session.
