AN ORDINANCE ALLOCATING THE AMOUNT OF TWO MILLION TWO HUNDRED EIGHTEEN THOUSAND NINE HUNDRED PESOS (PHP2,218,900.00) FOR THE ACQUISITION OF COCO LUMBER (CL) FOR THE EIGHT (8) BARANGAYS WITHIN THE JURISDICTION OF MUNTINLUPA CITY TO BE TAKEN FROM THE MUNTINLUPA CITY DISASTER RISK REDUCTION AND MANAGEMENT FUNDS (MCDRRMF)-30% OF QUICK RESPONSE FUNDS (QRF).


