WHEREAS, on 15th day of January 2019, Local Budget Circular No. 118 issued by the Department of Budget and Management (DBM), signed by Benjamin E. Diokno, Secretary, on the implementation of the Fourth Tranche Compensation Adjustment of Local Government Personnel;

WHEREAS, said Executive Order provides that in local government units, funding shall be subject to their financial capabilities;

WHEREAS, this Circular is issued to prescribe the guidelines, rules and regulations for the implementation of the fourth (4th) tranche compensation, adjustment in Local Government Units (LGUs) stipulated under EO No. 201, Series of 2016;

WHEREAS, the Salary Standardization Law Fourth Tranche Monthly Schedule shall take effect on January 1, 2019;

WHEREAS, the following are covered by this Circular:

- 1. All positions for salaried Local Government Unit personnel, whether regular, contractual, or casual in nature, appointive or elective, full time or part-time, now existing or hereafter created in LGUs;
- 2. All positions for barangay personnel which are paid monthly honoraria;

WHEREAS, excluded from the coverage of this Circular are those engaged without employer-employee relationship and funded from non-Personnel Services (PS) appropriations/budgets as follows:

- 1. Consultants and experts engaged for a limited period to perform specific activities or services with expected outputs;
- 2. Laborers engaged through job contracts (pakyaw) and those paid on piecework basis;
- 3. Students workers and apprentices;
- 4. Individual and groups of people whose service are engaged through job orders, contracts of service, or other similarly situated;

WHEREAS, there is available funds from the 2019 Executive Budget under the Personnel Services (PS);

NOW THEREFORE BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 8th Sangguniang Panlungsod of Muntinlupa, to approve the fourth (4th) tranche monthly salary schedule for the employees/personnel of the City Government of Muntinlupa which amount shall be taken from the 2019 Executive Budget of the City.
