AN ORDINANCE GRANTING THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (PHP500,000.00) AS INITIAL FUNDING FOR THE MUNTINLUPA CITY SCOUTING COUNCIL (MUNCISCO) AS ASSOCIATE COUNCIL OF THE BOY SCOUT OF THE PHILIPPINES (BSP) WHICH AMOUNT SHALL BE TAKEN FROM THE SPECIAL ACTIVITIES FUND (SAF) OF THE CITY MAYOR.

WHEREAS, the Muntinlupa City Scouting Committee (MUNCISCO) filed their application to operate as associate council to Boy Scouts of the Philippines;

WHEREAS, one of the requirements is to secure initial funding of Php 500,000.00 deposited in the bank under the Muntinlupa City Scouting Committee and allocating yearly subsidy to support the operation of the Council;

WHEREAS, as justified by the Chairman of Muntinlupa City Scouting Committee (MUNCISCO) that they can manage and operate as Associate Council;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 8th Sangguniang Panlungsod of Muntinlupa, in session assembled that:



SECTION 1. *Title* – This ordinance shall be known as an ordinance granting the amount of *Five Hundred Thousand Pesos (Php500.000.00)* as initial funding for **Muntinlupa City Scouting Council (MUNCISCO)** as Associate Council of the Boy Scout of the Philippines (BSP) which amount shall be taken from the Special Activities Fund (SAF) of the City Mayor.

SECTION 2. *Appropriation* – The amount of Five Hundred Thousand Pesos (Php500,000.00) shall be taken from the 2019 Executive Budget under the Special Activities Fund (SAF) of the City Mayor and appropriate the same to the Annual Executive Budget of the City.

SECTION 3. *Subsidy* – the City Government of Muntinlupa shall allocate and incorporate as subsidy to **Muntinlupa City Scouting Council (MUNCISCO)** every year thereafter/annually to the Executive Budget of the City.
