WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid for the project *rehabilitation of comfort room main/extension located at Pamantasan ng Lungsod ng Muntinlupa (PLMUN), NBP Reservation, Barangay Poblacion, Muntinlupa City* in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and likewise, posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, two bidders submitted letters of intent and application for eligibility, and one (1) was found eligible on **October 30**, **2018**;

WHEREAS, the amount appropriated for the said project as certified by the Budget Officer shall be taken from the 2017 Supplemental Budget;

WHEREAS, the Approved Budget for the Contract (ABC) for the project rehabilitation of comfort room Main/extension is One Million Nine Hundred Sixty Thousand Twenty Four Pesos and 71/100 (Php1,960,024.71);

WHEREAS, the project was awarded to *Gemwealth Construction and Trading* who being the responsive bidder for the project, *rehabilitation of comfort room Main/extension* located at *Pamantasan ng Lungsod ng Muntinlupa*, *NBP Reservation, Barangay Poblacion, Muntinlupa City*;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8TH Sangguniang Panlungsod, to authorize the *City Mayor Hon. Atty. Jaime R. 
