A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH KB INDUSTRIAL INC., FOR THE PROJECT FABRICATION AND INSTALLATION OF INTERIOR FIT-OUT AND DISPLAY FOR THE MUSEO NG MUNTINLUPA (PHASE 1) LOCATED AT LAGUERTA, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF FOURTEEN MILLION NINE HUNDRED THIRTY EIGHT THOUSAND THREE-HUNDRED SIXTY FOUR PESOS (PHP14,938,364.00) WHICH AMOUNT SHALL BE TAKEN FROM 2017 ANNUAL GENERAL FUND BUDGET.
