A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH KB INDUSTRIAL INC., FOR THE PROJECT FABRICATION AND INSTALLATION OF INTERIOR FIT-OUT AND DISPLAY FOR THE MUSEO NG MUNTINLUPA (PHASE 1) LOCATED AT LAGUERTA, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF FOURTEEN MILLION NINE HUNDRED THIRTY EIGHT THOUSAND THREE HUNDRED SIXTY FOUR PESOS (PHP14,938,364.00) WHICH AMOUNT SHALL BE TAKEN FROM 2017 ANNUAL GENERAL FUND BUDGET.
