A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH E.M. ANGELES ENTERPRISES FOR THE PROJECT INSTALLATION OF LIGHTS UNDER ALABANG VIADUCT (FOOTBRIDGE), BARANGAY ALABANG, MUNTINLUPA CITY AMOUNTING TO TWO MILLION ONE HUNDRED EIGHTEEN THOUSAND EIGHT HUNDRED TWENTY TWO PESOS (PHP2,118,822.00) WHICH AMOUNT SHALL BE TAKEN FROM 2017 **FUND** BUDGET THE 20% **GENERAL** UNDER DEVELOPMENT FUND (CDF).

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project construction of Multi-Purpose Building (Pavilion) located at Villa Carolina 1, Barangay Tunasan, Muntinlupa City in a newspaper of . general circulation, likewise posted at the Government Electronic Procurement System (GEPS) and City's Website and in conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, two (2) contractors/bidders submitted letter of intent and application for eligibility, and one (1) found eligible on December 28, 2018;

WHEREAS, two (2) bidders was submitted on December 28, 2018 and bid passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and requirements submitted by bidder with lowest calculated bid, E.M. Angeles Enterprises's bid has found responsive to Approved Budget for the Contract (ABC);

WHEREAS, the amount appropriated for the said project shall be taken from the 2018 Annual General Fund Budget under the 20% Community Development Fund (CDF);

WHEREAS, the Approved Budget for the Contract (ABC) for the project installation of lights under Alabang Viaduct (footbridge), Barangay Alabang, Muntinlupa City, amounts to Php2,122,378.81;

WHEREAS, the project was awarded to E.M. Angeles Enterprises who being the lowest bidder for the project installation of lights under Alabang Viaduct (footbridge), Barangay Alabang, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8TH Sangguniang Panlungsod, to authorize the *City Mayor Hon. Atty. Jaime R. Fresnedi,* in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **E.M. Angeles Enterprises** for the project installation of lights under Alabang Viaduct (footbridge), Barangay Alabang, Muntinlupa City amounting to Two Million One Hundred Eighteen Thousand Eight Hundred Twenty Two Pesos (Php2,118,822.00) which amount shall be taken from 2017 Annual General Fund Budget under the 20% Community Development Fund (CDF).
