A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH D.L CERVANTES CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF MUNTINLUPA AQUATIC CENTER RETAINING WALL (PHASE 1 AND PHASE 2A) LOCATED AT SPORTS COMPLEX, BARANGAY TUNASAN, MUNTINLUPA CITY AMOUNTING TO FIFTY TWO MILLION FOUR HUNDRED EIGHTY FOUR THOUSAND SEVEN HUNDRED EIGHTY FIVE PESOS AND 35/100 (PHP52,484,785.35) WHICH AMOUNT SHALL BE TAKEN FROM THE CONTINUING APPROPRIATIONS (2017 GENERAL FUND) UNDER INFRASTRUCTURE.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "**xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others**";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "**any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly**";

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "**the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances**";

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project construction of construction of **Muntinlupa Aquatic Center Retaining Wall (Phase 1 And Phase 2A) located at Sports Complex, Barangay Tunasan, Muntinlupa City** in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and likewise, City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, two (2) bidders submitted letter of intent and application for eligibility, and one (1) was found eligible December 18, 2018;

WHEREAS, two (2) bidders were submitted on December 18, 2018 and one bidder passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **D.L Cervantes Construction Corporation's** bid has found to be responsive to **Approved Budget for the Contract (ABC)**;

WHEREAS, the amount appropriated for the said project shall be taken from the Continuing Appropriation (2017 General Fund) under Infrastructure Fund;

WHEREAS, the **Approved Budget for the Contract (ABC)** for the project **Muntinlupa Aquatic Center Retaining Wall (Phase 1 And Phase 2A) located at Sports Complex, Barangay Tunasan, Muntinlupa City** is **Php53,192,012.76**;

WHEREAS, the project was awarded to **D.L Cervantes Construction Corporation** who being the responsive bidder for the project, **Muntinlupa Aquatic Center Retaining Wall (Phase 1 And Phase 2A) located at Sports Complex, Barangay Tunasan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8TH Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **D.L Cervantes Construction Corporation** for the project construction of **Muntinlupa Aquatic Center Retaining Wall (Phase 1 And Phase 2A)** located at Sports Complex, Barangay Tunasan, Muntinlupa City amounting to **Fifty Two Million Four Hundred Eighty Four Thousand Seven Hundred Eighty Five Pesos and 35/100 (Php52,484,785.35)** which amount shall be taken from the Continuing Appropriations (2017 General Fund) under Infrastructure.


