WHEREAS, on September 28, 2006, "*Typhoon Milenyo*" brought havoc to the City of Muntinlupa as it caused floods, loss of shelters, lives and properties, injuries and other calamities;

WHEREAS, such floods, loss of shelters, lives, properties, injuries and other calamities require clearing out operations, rehabilitation of damaged properties and evacuation of more or less 1,264 families or 3,966 persons;

WHEREAS, due to said calamities, evacuation centers were set-up by the City of Muntinlupa in different barangays;

RESOLVE THEREFORE, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod in session assembled declaring the City of Muntinlupa as in a "*State of Calamity*".
