WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, **"the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"**;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, **"xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned"**;

WHEREAS, the Ospital ng Muntinlupa requested to the Sangguniang Panlungsod an authority to enter into a contract with Inkrite Ink., provider for rent of various printer/copier/scanner (3-in-1) with unlimited supply of ink to be deployed in our service units;

WHEREAS, as the only hospital for the city of Muntinlupa capable of providing tertiary level healthcare, it is essential that the facility be enabled to contract with third party providers of equipment crucial to sustain our operations in the efficient and effective manner;
