WHEREAS, on July 1, 2019, the 9th Sangguniang Panlungsod adopted Resolution No. 19-001 "A resolution adopting the Internal Rules of Procedure for Ninth (9th) Sangguniang Panlungsod of Muntinlupa.";

WHEREAS, the said Internal Rules provides for the course of action and conduct of a member of the city Council in session as well as the parliamentary processes;

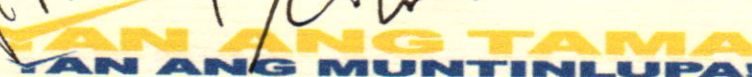
WHEREAS, due to the dynamism of the 9th City Council, there is a need to revise and amend a particular section of the internal rules particularly Section 61 thereof;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by 9th Sangguniang Panlungsod of Muntinlupa in Session assembled that:

SECTION 1. *Title* – This Resolution shall be known as "a resolution amending Section 61 of Resolution No. 19-001, entitled, "a resolution adopting the Internal Rules of Procedure for Ninth (9th) Sangguniang Panlungsod of Muntinlupa."

SECTION 2. The Provisions in Section 61 of the abovementioned Resolution read as follows:

Section 61. *First Reading* – The Secretary, upon the direction of the Majority Floor Leader, shall report all Ordinances and Resolutions and other matters to the Sanggunian Members for First Reading one (1) day prior to or before a Regular or Special Session.

The First Reading of proposed Ordinances or Resolutions and other matters shall be by title and, thereafter, the same shall be referred to the appropriate Committee by the Majority Floor Leader.

The erroneous referral of proposed Ordinances and Resolutions and other matters may be corrected any day after the approval of the Minutes.

Any member of the Sanggunian may move that the referral be declared erroneous and ask for its correction, or that the referral be made to two (2) or more Committees. However, the **Presiding Officer** may motu-proprio rectify an erroneous referral. In case the matter is referred to two (2) or more Committees, the **Presiding Officer** shall determine which shall be the **Lead Committee**.

SHALL BE AMENDED AND NOW BE READ AS FOLLOWS:

SECTION 61. First Reading – The Secretary, upon the direction of the Majority Floor Leader, shall report all proposed Ordinances and Resolutions and other matters to the Sanggunian Members for First Reading one (1) day prior to or before a Regular or Special Session.

The *First Reading* of proposed Ordinances or Resolutions and other matters shall be by title and, thereafter, the same shall be referred to the appropriate Committee by the Majority Floor Leader.

The erroneous referral of proposed Ordinances and Resolutions and other matters may be corrected any day after the approval of the Minutes.

Any member of the Sanggunian may move that the referral be declared erroneous and ask for its correction, or that the referral be made to two (2) or more Committees. However, the **Presiding Officer** may motu-proprio rectify an erroneous referral. In case the matter is referred to two (2) or more Committees, the **Presiding Officer** shall determine which shall be the **Lead Committee**. Thereafter, the Chairman of the Committee shall immediately conduct the required Committee/Public Hearing within Fifteen Days (15) after the referral.

The Sanggunian Secretary shall formally notify the Chairman of the Committee of the lapse of the fifteen (15)- day period and the Chairman is given seven (7) days from notice thereon to conduct the public/committee hearing.

Inaction of the Chairman within the additional seven (7) day period, shall motu-proprio vests upon the Vice-Chairman, or in his absence or inaction, a member, with the concurrence of the majority of the committee, the jurisdiction to take notice and proceed to undertake the necessary public/ committee hearing until its final approval/disapproval.




SECTION 4. Effectivity Clause – These amended Rules shall take effect on the date of its adoption.






