EXECUTIVE ORDER No. 07
Series of 2016

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides for the creation of a local health board in local government units, whose main function is to guarantee equitable, sustainable and quality health services to the general public, especially the poor;

WHEREAS, Executive Order No. 17, Series of 2013, provides for the creation of the Muntinlupa City Local Health Board (MCLHB), its composition and functions;

WHEREAS, there is a need to expand the composition of the MCLHB in order to reflect and manifest the growing health concerns of the city and to include the various agencies and offices that are vital in the accomplishment of the board's mandate;

NOW, THEREFORE, I, Atty. JAIME R. FRESNEDI, by virtue of the powers vested in me by law, do hereby ordain and decree that:

Section 1. Expansion of the Composition of the Muntinlupa City Local Health Board

Section 1 of Executive Order No. 17, Series of 2013, is hereby amended to read as follows, to wit:

1.1 Regular Members

1.3 The Special Members, owing to the particularity of the office they hold, may be invited to attend the Regular Meeting of the Regular Members, should there be an issue that directly relates to their respective office and that necessitates resolution. They shall serve as resource person and shall provide the requisite information to arrive at an inclusive and learned decision. In no case, however, shall they be allowed to vote similar to regular members.

Section 2. Meeting and Quorum

The second paragraph of Section 3, *supra*, is hereby amended to read as follows, to wit:

The MCLHB shall meet, pursuant to Section 103, *supra*, at least once every quarter, or as often as necessary. Moreover, a majority of the regular members shall constitute a quorum. The Chairperson or the Vice Chairperson shall be present whenever budgetary proposals are being prepared, considered or deliberated. The affirmative vote of the majority of the regular members shall be necessary to approve such proposals.

Section 3. Appropriation

Section 4, *supra*, is hereby amended to include a third paragraph, to wit:

An operational fund shall be appropriated from the budget of the City Health Office, and if warranted, from the Office of the City Mayor. This fund, subject to availability, shall answer for the projects, activities and expenses to be incurred by the MCLHB.

Section 4. Repealing Clause and Effectivity.

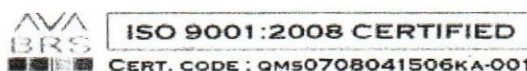
Section 6, *supra*, is hereby amended to read as follows, to wit:

All other orders, directives, memoranda and issuances inconsistent with any provision herein provided are hereby rendered ineffective.

This Executive Order shall take effect immediately.
