EXECUTIVE ORDER No. 08
 Series of 2019

**PROVIDING FOR THE CREATION OF THE MUNTINLUPA CITY ASSESSMENT TEAM
 FOR THE IMPLEMENTATION OF THE SEAL OF GOOD LOCAL GOVERNANCE
 FOR BARANGAY, ITS COMPOSITION AND FUNCTIONS**

WHEREAS, Section 5, Article II of the 1987 Philippine Constitution provides that “(t)he maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;”

WHEREAS, Section 3 (h) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that “(t)here shall be a continuing mechanism to enhance local autonomy not only by legislative enabling acts but also by administrative and organizational reforms;”

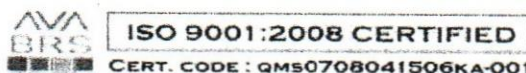
WHEREAS, Section 3 (m), *supra*, provides that “(t)he National Government shall ensure that decentralization contributes to the continuing improvement of the performance of local government units and the quality of community life;

WHEREAS, cognizant of the vital role of barangays in the overall development and transformation of the community and of the nation, the Department of the Interior and Local Government (DILG) shall implement the Seal of Good Local Governance for Barangay (SGLGB), and Award and Incentive Program, to encourage and challenge barangays to scale - up its performance and practices that accord primacy to the principles of accountability, transparency, and efficacy;

NOW, THEREFORE, I, Jaime R. Fresnedi, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Creation and Composition.

The Muntinlupa City Assessment Team for Seal of Good Local Governance for Barangay (SGLGB, *for brevity*) is hereby created, and it shall be composed of the following individuals, namely:

Section 2. Functions.


The SGLGB shall perform the following functions, namely:

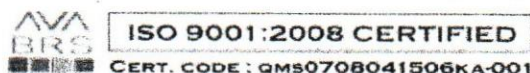
- (a) Gather and collect data;
- (b) Validate and Certify the foregoing through documentary review, interview and on-site inspection;
- (c) Perform such other functions as may be necessary to achieve the foregoing or as may be directed by competent authority.

Section 3. Effectivity Clause.

This Executive Order shall take effect immediately upon signing and shall remain in full force and effect until revoked, rescinded, amended or suspended accordingly.
