EXECUTIVE ORDER NO. 8
Series of 2020

**PROVIDING FOR THE CREATION OF THE TRICYCLE TASK FORCE
OF THE CITY OF MUNTINLUPA, ITS COMPOSITION AND FUNCTIONS**

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that a local government unit shall “maintain peace and order, and preserve the comfort and convenience of their inhabitants;”

WHEREAS, Section 448 (3) (vi), *supra*, provides that a municipality shall “(s)ubject to the guidelines prescribed by the Department of Transportation and Communications, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality;”

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2020-036, “Prohibiting Tricycles, Pedicabs, and Motorized Pedicabs from Operating on National Highways”;

WHEREAS, a concerted and unified effort should be made among officials and employees of the City Government of Muntinlupa, on one hand, and among stakeholders, on another, in order to ensure coordinated and effective response to urban transportation problems;

NOW, THEREFORE, I, Jaime R. Fresnedi, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Creation and Composition.

The Tricycle Task Force of the City of Muntinlupa (TTF, for brevity) is hereby created, and it shall be composed of the following individuals, with their respective designations, namely:

Membership in the TTF is a function of the office of which the member occupies. Hence, the resignation, transfer, removal, termination, severe illness, incapacity, death, or similarly situated circumstance of the member shall entitle the successor to assume membership without the need for the issuance of another order or instrument.

For purposes of regulation, the Secretariat shall correspond with the National Government agencies above-mentioned in sub-section 1, and shall secure the names of the representatives. As much as possible, one name shall be submitted, and this individual shall sit as member until circumstances mentioned in the preceding paragraph take place. In such

event, the Head of the Agency concerned shall furnish the Secretariat the name of the successor.

Section 2. Functions.

The TTF shall perform the following functions, namely:

- a. Conduct meetings, public consultations, and hearings with stakeholders, and conduct surveys or ocular inspections of the zone or specific area of tricycle operations with particular attention to the following, namely:
 - i. Rationalize the authorized routes of all tricycles and pedicabs to in order to keep them away from national roads and conveyances;
 - ii. Identify from competent authority the national roads and conveyances within the City of Muntinlupa;
 - iii. Determine the extent of national roads and conveyances that can be used by tricycles and pedicabs in the event that no alternate routes are available;
- b. Draft, update and cause the dissemination of the Tricycle Route Plan of the City of Muntinlupa within thirty (30) days from the execution and issuance of this Executive Order;
- c. Oversee the implementation of the Traffic Route Plan, and submit recommendations and reports to concerned Committees of the Sangguniang Panlungsod, which shall serve as foundation of possible legislation and enactment of a City Ordinance;
- d. The Traffic Route Plan (TRP, for brevity) shall contain the following, namely:
 - i. Schematic Map, which clearly shows the following, namely:
 1. the location of tricycle terminals and tricycle routes;
 2. the national roads and conveyances wherein four-wheel vehicles with weight of 4 tons or more and wherein allowed normal moving speed can exceed forty (40) kilometres per hour;
 3. the portions or parts of national roads and conveyances wherein tricycles or pedicabs may be allowed to traverse in the event an alternate route is absent.
 - ii. In order to ensure safety and to disseminate proper information, additional details of the TRP shall include the following, namely:
 1. the installation of visible and appropriate signages, marks for lanes and other safety features for the guidance and protection of all vehicles going through the national roads and conveyances;

2. the Information, Education and Communication (IEC) materials on all matters related to proper implementation of the TRP;
 3. the color-scheme or any highly visible emblem or sign employed on tricycles and pedicabs;
 4. the proposed penalties to be imposed on any violator;
 5. the Speed Limit Enforcement on national roads and conveyances; and
- iii. The TRP shall be valid for two (2) years from the issuance of DILG Memorandum Circular No. 2020-036.
- e. Recommend measures and directives to the City Mayor, and the Vice Mayor and Sangguniang Panlungsod to empower personnel and expedite solutions to issues and concerns; and
- f. Perform such other functions as may be directed by competent authority, or as may be necessary to achieve the foregoing.

Section 3. Secretariat.

Atty. Karen B. Baldonasa shall act as Head of the Secretariat, which body shall be composed of select staff members of the City Legal Office. The names of the select staff members shall immediately be provided to all members of the TTF.

The Secretariat shall be responsible for the following, namely:

- a. Issue Notices of Meetings, whether regular or special, setting forth clearly the agenda;
- b. Prepare logistical support to each meeting;
- c. Write down, record and disseminate the Minutes of Meeting;
- d. Write down, send and record all correspondence;
- e. Facilitate all administrative concerns and processes;
- f. Perform such other functions as may be directed by competent authority, or as may be necessary to achieve the foregoing.

Section 4. Meetings.

The TTF shall meet regularly once a month. Whenever warranted, a special meeting may be called.

Section 5. Funding.

All expenses that may be incurred by the TTF shall be taken from the Trust Fund of the MTMB.

Section 6. Repealing Clause.

All issued orders and directives found inconsistent with this Executive Order shall be deemed repealed, revoked, or amended accordingly.

Section 7. Separability Clause.

In the event that any provision herein found shall be judicially declared illegal or infirm, untouched provisions shall remain in full force and effect.

Section 8. Effectivity Clause.

This Executive Order shall take effect immediately upon signing, and it shall remain in full force and effect until repealed, revoked, or amended accordingly.
