**EXECUTIVE ORDER NO. 69**

**PROVIDING FOR FURTHER AMENDMENTS TO SECTION 2 OF EXECUTIVE ORDER NO. 9, SERIES OF 2013, AS INITIALLY AMENDED BY EXECUTIVE ORDER NO. 35, SERIES OF 2014, FOR THE PURPOSE OF DEVOLVING THE POWERS TO CONDUCT PRELIMINARY INVESTIGATION AND TO ACT AS PROSECUTOR IN FORMAL INVESTIGATION IN ADMINISTRATIVE CASES FILED PURSUANT TO EXECUTIVE ORDER 292, SERIES OF 1987, OR THE ADMINISTRATIVE CODE OF THE PHILIPINES, AND THE REVISED RULES ON ADMINISTRATIVE CASES IN THE CIVIL SERVICE (RRACCS)**

**WHEREAS**, Executive Order No. 9, Series of 2013, was issued to provide for the reorganization and institutionalization of the Anti-Graft Board of the City of Muntinlupa, Its Composition and Functions;

**WHEREAS**, the Board's functions were earlier amended thru Executive Order No. 35, Series of 2014, for the purpose of integrating and harmonizing the functions of the Anti-Graft Board of the City Government of Muntinlupa with pertinent provisions of DILG Circular No. 87-02, dated 22 January 1987;

**WHEREAS**, with the investigative powers of the Board, it is sound to devolve to it the power to conduct Preliminary Investigation in administrative cases allowable to be performed by the "authorized representative" of the disciplining authority under the RRACCS;

**WHEREAS**, for pragmatic purposes, it is desirable that the Board be the one to prosecute the case Before the Board of Discipline once it reaches Formal Investigation and present the evidence it earlier gathered and familiarized with;

**NOW, THEREFORE, I, ATTY. JAIME R. FRESNEDI**, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Additional Functions.

Section 2 of Executive Order No. 9, Series of 2013, as amended by Executive Order No. 35, Series of 2014 is hereby amended to include the following additional functions:



- a. To conduct preliminary investigation in administrative cases, including the power to issue a show-cause memorandum, under Rule 4 of the RRACCS; and
- b. To present the evidence it gathered in the Preliminary Investigation and actively prosecute the case during the Formal Investigation before the Board of Discipline, with power of substitution if the need of a more legally equipped prosecutor arises.

This Executive Order shall take effect immediately.
