**EXECUTIVE ORDER NO. 14**  
 Series of 2017

**PROVIDING FOR FURTHER AMENDMENTS TO EXECUTIVE ORDER NO. 15,  
 SERIES OF 2015, WHICH AMENDED EXECUTIVE ORDER NO. 14, SERIES OF 2013,  
 ON THE REORGANIZED COMPOSITION OF THE MUNTINLUPA CITY  
 DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MCDRRMC)**

**WHEREAS**, the Muntinlupa City Disaster Risk Reduction and Management Council (MCDRRMC) was constituted by virtue of Executive Order No. 14, Series of 2013, issued on 12 November 2013, thereby providing also for its composition and functions, and this was amended by Executive Order No. 15, Series of 2015;

**WHEREAS**, the composition provided by Executive Order No. 15, Series of 2015 involves forty (40) individuals;

**WHEREAS**, the council, in its discharge of its functions, seeks to involve more sectors in the direct management of resources, particularly after the audit finding that membership should be in clusters for quicker and more efficient response and that more representation from civil society groups should be in place;

**NOW, THEREFORE, I, Atty. JAIME R. FRESNEDI, City Mayor of Muntinlupa**, by virtue of the powers vested in me by law do hereby decree and order that:

Section 1. Reorganization of the Composition of Membership of the MCDRRMC

Section 1 of Executive Order No. 14, Series of 2013, as amended by Executive Order No. 15, Series of 2015, is hereby amended to read as follows, to wit:

The Muntinlupa City Disaster Risk Reduction and Management Council (*MCDRRMC, for brevity*) shall be composed of the following individuals, grouped together in clusters, with their respective designations, namely:

- a. City Mayor of Muntinlupa..... Chairperson;
- b. Majority Floor Leader, Sangguniang Panlungsod.....Vice Chairperson;
- c. Chairman, Committee on Disaster Risk Reduction  
and Management .....Member;

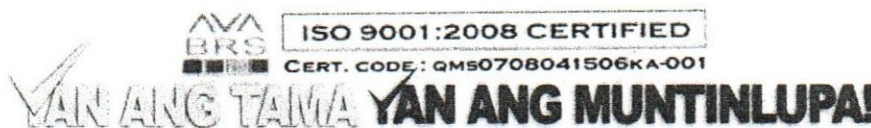

- c. Head, City Legal Office.

Section 4. Transportation Allowance.

Subject to availability of funds, proper documentation, reportorial requirements, and documented attendance, each member of the MCDRRMC shall receive the amount of Php 2,500.00 at the end of each quarter.

Section 5. Effectivity

This executive order shall take effect immediately and shall remain subsisting until revoked, rescinded, modified or altered accordingly.
