EXECUTIVE ORDER No. 14
Series of 2018

**PROVIDING FOR AMENDMENTS TO EXECUTIVE ORDER NO. 01, SERIES OF 2015,
THEREBY SPECIFYING THE NAMES OF THE MEMBERS OF THE COUNCIL AND
OF THE SECRETARIAT, AND MODIFYING ITS FUNCTIONS**

WHEREAS, Section 51, Article VII of Republic Act No. 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002 provides that "(l)ocal government units shall appropriate a substantial portion of their annual budgets to assist in or enhance the enforcement of this Act giving priority to preventive or educational programs and the rehabilitation or treatment of drug dependents;"

WHEREAS, the City Government of Muntinlupa converted and renamed the Muntinlupa Anti-Drug Abuse Prevention and Control Council into the Drug Abuse Prevention and Control Office, in compliance to City Ordinance No. 2002-067, dated 17 October 2002, serving as the focal point and effective mechanism in orchestrating the campaign against illegal drugs;

WHEREAS, drug abuse continues to be a societal menace, requiring concerted and multi-faceted responses and multi-sectoral involvement;

WHEREAS, the Department of the Interior and Local Government Memorandum Circular No. 98-227, dated 02 December 1998, enjoins all local government units to create the local Anti-Drug Abuse Council with corresponding composition, roles and responsibilities;

WHEREAS, in order to strengthen and revitalize the campaign against illegal drug use, and, for the foregoing reasons, the creation of the Muntinlupa Anti-Drug Abuse Council (MADAC) is both essential and immediate;

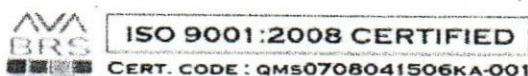
NOW, THEREFORE, I, Jaime R. Fresnedi, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby decree and order that:

Section 1. Composition of the Muntinlupa Anti-Drug Abuse Council (*Council, for brevity*).

In the event of resignation, transfer, cessation of employment, incapacity, or other similarly-situated circumstance of any member included in the enumeration above, the successor shall assume membership in the Council without need for further issuance of any instrument. In the case of members belonging to the private sector in the same situation abovementioned, the City Mayor shall appoint another individual according to recommendations made by the other members of the Council and the Drug Abuse Prevention and Control Office (DAPCO).

Section 2. Functions.

The Council shall perform the following functions, namely:

- a. Observe proper and regular attendance in all meetings called for;
- b. Serve as the focal point through which various individuals and organizations work and cooperate together in the planning, implementation and evaluation of programs and activities regarding drug abuse prevention;
- c. Provide an effective framework for the coordination of existing services and programs, as well as those for development in the future;
- d. Provide the mechanism for sourcing of funds, volunteers, facilities, technical expertise, among others, and coordinate with other individuals and organizations, both private and public, for this purpose;
- e. Perform such other functions as the City Mayor may direct and as necessary for the successful implementation of the foregoing.

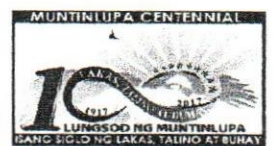
Section 3. Secretariat.

The Secretariat of the Council shall be composed of the following staff members from the DAPCO, namely:

The Secretariat shall be responsible for the issuance of notices of meeting, whether regular or special; for the logistical support thereto; for the writing, recording and dissemination of the minutes of meeting; for the preparation and filing of correspondences; and for other matters brought it.

Section 4. Effectivity.

This Executive Order shall effect immediately upon signing, and shall remain in full force until revoked, rescinded, amended or superseded accordingly.
