EXECUTIVE ORDER No. 15
Series of 2017

PROVIDING FOR THE INCLUSION OF JANALODIN T. GUILING IN THE COMPOSITION OF THE PEACE AND ORDER COUNCIL OF THE CITY OF MUNTINLUPA, AND AMENDING, FOR SAID PURPOSE, EXECUTIVE ORDER NO. 5-C, DATED 01 OCTOBER 2015, AMENDED SUBSEQUENTLY BY EXECUTIVE ORDER NO. 23, DATED 28 OCTOBER 2016

WHEREAS, Section 116 of Republic Act 7160, otherwise known as the Local Government Code of 1991, and Executive Order No. 773, Series of 2009, signed by President Gloria Macapagal-Arroyo, the Peace and Order Council of the City of Muntinlupa is hereby reorganized and reconstituted in order to reflect changes in its composition;

WHEREAS, Executive Order No. 5-C, dated 01 October 2015, amended by Executive Order No. 23, dated 28 October 2016, provides for the aforementioned reorganization and reconstitution of the Peace and Order Council of the City of Muntinlupa (POCCM);

WHEREAS, there is a necessity to expand the composition of the POCCM, particularly on the inclusion of Mr. Janalodin T. Guiling, who sits as Officer in Charge of the Muntinlupa City Muslim Affairs Office (MCMAO);

NOW, THEREFORE, I, Atty. JAIME R. FRESNEDI, by virtue of the powers vested in me by law, do hereby ordain and decree that:

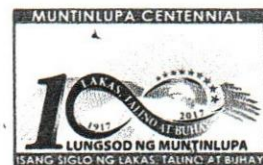
Section 1. Expansion of the Composition.

The Composition of the Peace and Order Council of the City of Muntinlupa (POCCM) shall include the following, amending, for said purpose, Section 1 of Executive Order No. 23, Series of 2016, dated 28 October 2016, namely:

cc. Janalodin T. Guiling : Member;
OIC, MCMAO.

Section 2. Compensation.

Pursuant to Section 4 of Executive Order No. 23, Series of 2016, Mr. Guiling shall receive the amount of Two Thousand Five Hundred (Php2,500.00) Pesos per month.


Section 3. Seperability Clause.

This Executive Order shall take effect immediately, and shall remain in effect until subsequently amended, revoked, rescinded or superseded accordingly.
