EXECUTIVE ORDER No. 18
Series of 2019

PROVIDING FOR THE CREATION OF THE MUNTINLUPA CITY AUDIT TEAM FOR THE IMPLEMENTATION OF THE ANTI-DRUG ABUSE COUNCIL PERFORMANCE AUDIT, ITS COMPOSITION AND FUNCTIONS

WHEREAS, Republic Act No. 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002, embodies the National Government's commitment to eradicate the illegal drug problem, and, in particular, Article VII thereof highlights the important participation of local government units therein through the establishment of Special Drug Education Centers, continuous conduct of advocacy activities, and allocation of resources;

WHEREAS, the Philippine Anti-Illegal Drug Strategy (PADS), approved by President Rodrigo R. Duterte on October 2018, provides the blueprint for the government's strategies and programs in addressing the illegal drug use problem and placing the Department of the Interior and Local Government (DILG), alongside local government units, at the forefront of the anti-illegal drug program;

WHEREAS, the Anti-Drug Abuse Councils (ADACs) of local government units, pursuant to the aforementioned PADS, are enjoined to revitalize and strengthen their respective administration of anti-illegal drug programs, including compliance to allocation of fixed amount from their respective annual budgets for such purpose;

WHEREAS, to ensure the continuous improvement and performance of ADACs in the implementation of anti-illegal drug activities, the DILG will conduct a Performance Audit to ADACs to ascertain the functionality, i.e., high, moderately high, moderately low, and low, at the barangay, municipal, city and provincial levels;

NOW, THEREFORE, I, JAIME R. FRESNEDI, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Creation and Composition.

The Muntinlupa City Audit Team for the Anti-Drug Abuse Council Performance Audit is hereby created (*Audit Team, for brevity*), and it shall be composed of the following individuals, namely:

Section 2. Functions.

The Audit Team shall perform the following functions, namely:

- Collect data that are accurate, current and relevant;
- Review and assess documents submitted before it;
- Coordinate with the Anti-Drug Abuse Functionality Monitoring System Focal Person to ensure smooth and orderly facilitation of all documents;
- Perform such other functions as may be directed by competent authority, or as may be deemed necessary to achieve the foregoing.


Section 3. Repealing Clause.

Any order or directive inconsistent with any of the provisions found herein shall be deemed revoked, repealed, rescinded or amended accordingly.

Section 4. Effectivity Clause.

This Executive Order shall take effect immediately, and it shall remain in full force and effect until revoked, repealed, rescinded or amended accordingly.
