EXECUTIVE ORDER No. 19
Series of 2016

PROVIDING FOR AMENDMENTS TO EXECUTIVE ORDER NO. 3 AND NO. 3-A,
ON THE REORGANIZATION OF
THE PEOPLE'S LAW ENFORCEMENT BOARD,
ITS COMPOSITION AND SECRETARIAT

WHEREAS, the 7th Sangguniang Panlungsod of Muntinlupa passed Resolution No. 14-053, Series of 2014, otherwise known as "A Resolution Creating The People's Law Enforcement Board;

WHEREAS, pursuant to the above-cited Resolution, the People's Law Enforcement Board shall be composed of the following:

- a. *A member of the Sangguniang Panlungsod/Bayan chosen by his/her respective sanggunian;*
- b. *A Punong Barangay of the city or municipality concerned chosen by the LIGA ng mga Barangay; and*
- c. *Three (3) other members, who can be removed only for cause, chosen by the City/Municipal Peace and Order Council from among the respected members of the community known for their probity and integrity, one (1) of whom must be a woman and another, a member of the BAR or in the absence thereof, a college graduate, or, a principal of the Central Elementary School in the locality.*

The Chairperson of the PLEB shall be elected from among its members. Except, as provided in this Section or as may be provided by law, a public official or employee is disqualified for appointment or designation as member of the PLEB;

WHEREAS, there is a need to introduce new members to the PLEB, which replaced those enumerated under Resolution No. 14-053, Series of 2014, issued by the Sangguniang Panlungsod ng Muntinlupa;

WHEREAS, there is a need to provide amendments to Executive Order No. 3-B, which amended Executive Order No. 3-A, in order to reflect current realities on the staffing requirements of the Secretariat of the PLEB;

WHEREAS, Atty. Victor C. Lizardo III was elected, in the first meeting of the members of the PLEB, as Chairperson thereof;

WHEREAS, the **Hon. Mamerto T. Sevilla, Jr.**, Punong Barangay, Barangay Sucat, was recommended and chosen by the Liga ng mga Barangay Muntinlupa City Chapter;

WHEREAS, (Ret.) L/Col. Estrella N. Tabuco, (ret.) J/Col. Demetrio A. Alvarez and Atty. Victor C. Lizardo, III were chosen and recommended by the City Peace and Order Council;

WHEREAS, Councilor Lucio B. Constantino, was chosen and recommended by the Members of the City Council to represent the Sangguniang Panlungsod ng Muntinlupa in the People's Law Enforcement Board (PLEB) as per SP Resolution No. 16-009, Series of 2016;

NOW, THEREFORE, I, Atty. JAIME R. FRESNEDI, by virtue of the powers vested in me by law, do hereby ordain and decree that:

Section 1. Reorganization of the Composition of the People's Law Enforcement Board.

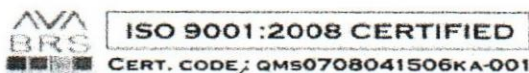
The People's Law Enforcement Board (PLEB, *for brevity*) shall herein be composed of the following individuals, namely:

1. Atty. Victor C. Lizardo, III
2. Hon. Mamerto T. Sevilla, Jr., *Punong Barangay, Barangay Sucat*
3. L/Col. Estrella N. Tabuco (ret.)
4. J/Col. Demetrio A. Alvarez (ret.)
5. Hon. Lucio B. Constantino, *Sangguniang Panlungsod ng Muntinlupa*.

Section 2. Reorganization of the Secretariat of the PLEB and its Functions.

The Secretariat of the PLEB shall be responsible for handling the administrative functions of recording, filing and similarly situated tasks indispensable for the smooth, effective and expeditious discharge of all functions of the PLEB. It shall be composed of the following, namely:

Moreover, the Secretariat shall be responsible for handling the administrative functions of recording, filing and similarly situated tasks indispensable for the smooth, effective and expeditious discharge of all functions of the PLEB.

Section 3. Honorarium.

The Members and Secretariat of the PLEB shall receive a reasonable amount as allowance, provided in aforementioned Resolution No. 14-053.

Section 4. Term.

The Members and Secretariat of the PLEB shall have a term of office in accordance with SP Resolution 14-053.

This Executive Order shall take effect immediately, and shall remain in full force, unless otherwise amended, revoked, rescinded or suspended.
