EXECUTIVE ORDER No. 19  
Series of 2020

**PROVIDING FOR DECLARATION OF EXTREME LOCALIZED COMMUNITY QUARANTINE  
IN MORNING BREEZE, BARANGAY ALABANG, CITY OF MUNTINLUPA, AND  
FOR THE PARAMETERS OF CONCERNED DEPARTMENTS AND OFFICES  
IN THE ENFORCEMENT THEREOF**

**WHEREAS**, Resolution No. 5, Series of 2020, issued by the Inter-Agency Task Force (IATF) on Emerging and Infectious Diseases, dated 25 May 2020, provides for the Requirements for LGU Appeals for Classification of LGU-Wide Community Quarantine and for LGU Declaration of Localized Community Quarantine;

**WHEREAS**, an unnumbered Regional Memorandum, issued by the Department of the Interior and Local Government (DILG), dated 25 May 2020, provides for the Requirements for LGU Appeals for Classification on LGU-Wide Community Quarantine and for LGU Declaration of Localized Community Quarantine;

**WHEREAS**, Morning Breeze in Barangay Alabang, City of Muntinlupa, reported a troubling increase in the number of confirmed cases of covid-19 among its residents, including probable and suspect cases;

**WHEREAS**, on 27 May 2020, the City Health Office (CHO) conducted targeted mass testing for covid-19 among residents of Morning Breeze, and six (6) immediately were confirmed using polymerase chain reaction (PCR) testing. In the meantime, the CHO is still waiting for the results of four (4) symptomatic patients, who are likewise all residents of the same area;

**WHEREAS**, it is an absolute necessity to contain the spread of the corona virus among the residents thereof, and, towards this, a declaration of extreme localized community quarantine is imperative;

**NOW, THEREFORE, I, Jaime R. Fresnedi, City Mayor of Muntinlupa**, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Declaration.

An Extreme Localized Community Quarantine (ELCQ) is hereby declared over Morning Breeze in Barangay Alabang, City of Muntinlupa. This shall be effective from 12:01 am of 03 June 2020, Wednesday, to 11:59 pm of 05 June 2020, Friday.

Section 2. Functions.

In order to ensure the successful containment of the corona virus among the residents of Morning Breeze and the safety and health of the residents thereof, the following entities shall perform the functions enumerated below:

A. Philippine National Police – Muntinlupa City Station

Provide round the clock and overall security of the residents and personnel assigned in Morning Breeze and ensure peace and order.

B. Philippine Coast Guard – Bayanan Sub-Station

Provide round the clock and overall security along the Laguna Lake coastline of Morning Breeze.

C. City Health Office

Provide the mass testing kits and personnel to conduct the same among the residents; ensure that the results thereof are properly handled; provide all logistical support for the general well-being and health of all residents.

D. Ospital ng Muntinlupa

Provide the tertiary medical care, when warranted, and the isolation units, as deemed necessary.

E. Disaster Risk Reduction and Management Office

Provide the logistical requirements of all departments and offices operating in the ELCQ.

F. Social Services Department

Provide the necessary relief food packs to cover all meals and sustain the residents in the three-day effectivity of the ELCQ. This may exceed the initially planned four hundred fifty-five (455) units of relief food packs.

G. City Planning and Development Office

Provide relevant, timely and necessary data to assist the work done by all concerned departments and offices.

H. Public Information Office

Facilitate the dissemination of relevant, correct and necessary information to concerned offices of the City Government, including the Sangguniang Panlungsod, and agencies of the National Government; release press briefings and update proper media channels on the developments in the enforcement of the ELCQ.

I. Department of the Interior and Local Government -  
Muntinlupa City Local Operations Office

Ensure that all concerned departments and offices comply to the requirements set forth by the Regional IATF on declaration of ELCQ.

J. Barangay Government of Alabang

Provide augmentation and support in terms of law enforcement and peace and order, distribution of relief food packs, provision of medical supplies and personnel, and in other areas where assistance is needed.


Section 3. Separability Clause.

In the event that any provision herein found is judicially struck down as illegal or administratively declared as infirm, untouched provisions shall remain in full force and effect.

Section 4. Effectivity Clause.

This Executive Order shall take effect immediately upon its signing, and it shall remain in full force and effect unless repealed, revoked or amended accordingly.
