**PROVIDING FOR THE DESIGNATION OF ENGR. ROBERT GASCON ELAMPARO
AS THE LOCAL INFRASTRUCTURE INVESTMENT COORDINATING OFFICER
OF THE CITY OF MUNTINLUPA**

WHEREAS, Section 2 (paragraph a) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, affirms that the State shall provide for a responsive and accountable local government structure instituted through a system of decentralization whereby local government units shall be given more powers, authority, responsibilities and resources;

WHEREAS, Section 455 (b) (xvi), *supra*, provides that the City Mayor shall "(c)all upon any national official or employee stationed in or assigned to the city to advise him on matters affecting the city and to make recommendations thereon; coordinate with said official or employee in the formulation and implementation of plans, programs and projects; xxx;"

WHEREAS, the City Government of Muntinlupa is embarking on an aggressive and detailed endeavor to promote the city as an attractive investment destination for prospective investors, businessmen and merchants;

NOW, THEREFORE, I, Atty. Jaime R. Fresnedi, City Mayor of Muntinlupa, by virtue of the powers vested upon me by law, do hereby ordain and decree that:

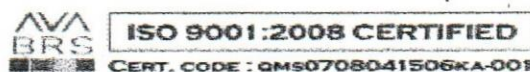
Section 1. Designation.

Engr. Robert Gascon Elamparo, Engineer III, is hereby designated as the Local Infrastructure Investment Coordinating Officer (LIICO, *for brevity*) of the City Government of Muntinlupa.

Section 2. Roles and Functions.

The LIICO shall perform the following roles and functions, namely:

- a. Study the possible policies and programs that the City Government can formulate and implement in order to attract infrastructure investments in the city, and devise concrete courses of action that may be submitted to the Office of the City Mayor for execution;

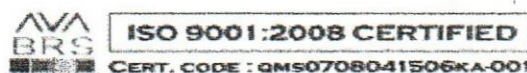
- b. Facilitate the creation of a mechanism for an aggressive, systematic, coordinated, and sustained promotion and marketing of the City of Muntinlupa as an attractive infrastructure investment location;
- c. Provide information to prospective investors on the positive and lucrative prospects of investing in the city, including a local economic database containing relevant facts and figures, in coordination with the Local Economic Investment Promotion Officer (LEIPO), the City Competitiveness Office (CCO), the Business Permits and Licensing Office (BPLO), and related offices and agencies;
- d. Provide assistance to prospective investors and construction companies, which may include personal intervention, if necessary, in securing permits and payment of fees, whether from city departments and offices or from national government agencies;
- e. Provide the Office of the City Mayor with relevant information which may be used as basis for legislation endorsed to the Sangguniang Panlungsod and enhance the attractiveness and competitiveness of the city as an infrastructure investment location;
- f. Establish close linkages with private chambers of commerce and other business groups in order to promote the city, including coordination with investment promotion campaigns, if necessary;
- g. Perform such other functions as may be necessary to accomplish the foregoing.

Section 3. Effectivity.

This Executive Order shall take effect immediately, and shall continue to be in effect until revoked, rescinded, amended or superseded accordingly.
