EXECUTIVE ORDER No. 20  
Series of 2019

PROVIDING FOR THE CREATION OF THE CITY OF MUNTINLUPA  
ASSESSMENT TEAM FOR THE MONITORING OF THE FUNCTIONALITY OF THE  
BARANGAY DEVELOPMENT COUNCILS, ITS COMPOSITION AND FUNCTIONS

**WHEREAS**, Section 106 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(e)ach local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian. For this purpose, the development council at the provincial, city, municipal, or barangay level, shall assist the corresponding sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction;"

**WHEREAS**, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2019-69, and dated 15 May 2019, entitled "Guidelines in the Monitoring (*sic*) the Functionality of the Barangay Development Council," which amended Memorandum Circular No. 2009-109;

**WHEREAS**, Item 5.5., *supra*, provides the Functionality Indicators therefor, which aims to assess the effectiveness of the performance of the BDC vis-à-vis their functions as provided for under the law;

**WHEREAS**, the assessment of the functionality of the BDC shall be conducted on an annual basis, and the results thereof for Year 2019 shall serve as benchmark data in the determination of the performance of all BDCs in the City of Muntinlupa, which will enable the DILG and partner agencies in providing interventions and capacities should the BDC fail to reach its desired level of functionality;

**NOW, THEREFORE, I, Jaime R. Fresnedi**, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Creation and Composition.

The City of Muntinlupa Assessment Team for the Monitoring of the Functionality of the Barangay Development Councils (CMAT, *for brevity*) is hereby created, and it shall be composed of the following individuals, namely:

Section 2. Functions.

The CMAT shall perform the following functions, namely:

- (a) Assess the functionality of the respective Barangay Development Councils of all nine (9) barangays of the City of Muntinlupa based on the submitted Barangay Self-Assessment Form;
- (b) Review and evaluate the means of verification and relevant documents for the assessment of BDC functionality;
- (c) Conduct validation activities whenever necessary;
- (d) Submit consolidated monitoring report and assessment results to the DILG Regional Office, National Capital Region, through the DILG Muntinlupa City Local Government Operations Office.

Section 3. Secretariat.

The staff members of the DILG Muntinlupa City Local Government Operations Office shall act as the Secretariat of the CMAT. It shall be responsible for the issuance of Notice of Meeting; for logistical support in the conduct of meetings, whether regular or special; for the writing down, filing and dissemination of Minutes of Meeting; for the receiving, writing down, sending and filing of all correspondence; and for all related functions.

Section 4. Repealing Clause.

All previous orders and similar directives inconsistent with any provision herein shall be deemed revoked, rescinded, or amended accordingly.


Section 5. Separability Clause.

Section 6. Effectivity Clause.

This Executive Order shall take effect immediately upon signing, and it shall remain in full force and effect until revoked, rescinded, or amended accordingly.
