**EXECUTIVE ORDER No. 20**  
Series of 2020

**PROVIDING FOR AMENDMENT TO EXECUTIVE ORDER No. 19, SERIES OF 2020,  
ISSUED ON 02 JUNE 2020, ON THE EXTENSION OF  
THE EXTREME LOCALIZED COMMUNITY QUARANTINE IN MORNING BREEZE,  
BARANGAY ALABANG, CITY OF MUNTINLUPA**

**WHEREAS**, Executive Order No. 19, Series of 2020, issued on 02 June 2020, provides for the declaration of Extreme Localized Community Quarantine (ELCQ) in the community of Morning Breeze, Barangay Alabang, City of Muntinlupa, due to the troubling increase in the number of confirmed cases of covid-19 among the residents thereof;

**WHEREAS**, based on the recommendation of the City Health Office, in order for that office to properly handle the results of the Polymerase Chain Reaction (PCR) tests conducted among the residents thereof, which number one hundred thirty-one (131), while it awaits the results of thirty-three (33) probable cases, an extension of the ELCQ mentioned above is ideal and necessary;

**WHEREAS**, concerned and relevant departments and offices of the City Government of Muntinlupa, which includes the Disaster Risk Reduction and Management Office (DRRMO), the Social Services Department (SSD), the Philippine National Police - Muntinlupa City Station, the Philippine Coast Guard - Bayanan Sub-Station, and the Department of the Interior and Local Government, Muntinlupa City Local Operations Office, concur with the recommendation stated above, and all submitted this recommendation to the Office of the City Mayor and to the Barangay Government of Alabang, through Punong Barangay Christine May Abas, and both accepted the same recommendation;

**NOW, THEREFORE, I, Jaime R. Fresnedi, City Mayor of Muntinlupa**, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Extension of the Extreme Localized Community Quarantine.

Amendment to the original three-day period of the Extreme Localized Community Quarantine (ELCQ), which is 12:01 am of 03 June 2020 to 11:59 pm of 05 June 2020 is provided. Henceforth, the period shall from hereon cover fourteen (14) days, namely:

From 12:01 am of 03 June 2020, Tuesday to 11:59 pm of 16 June 2020, Tuesday.

Section 2. Functions.

The functions of concerned and relevant departments and offices enumerated under Executive Order No. 19, Series of 2020, shall remain subsisting and effective for the new period mentioned in the preceding paragraph.

Section 3. Repealing Clause.

An order or a directive that is inconsistent with any provision herein found is deemed repealed, revoked or amended accordingly.

Section 4. Separability Clause.

In the event that any provision herein found is judicially struck down as illegal or administratively declared as infirm, untouched provisions shall remain in full force and effect.

Section 5. Effectivity Clause.

This Executive Order shall take effect immediately upon its signing, and it shall remain in full force and effect unless repealed, revoked or amended accordingly.
