**AMENDING THE COMPOSITION OF THE MUNTINLUPA CITY - BIDS AND AWARDS COMMITTEE (M-BAC) AND OF THE OSPITAL NG MUNTINLUPA - BIDS AND AWARDS COMMITTEE (OSMUN-BAC), AS PROVIDED IN E.O. NO.14, SERIES OF 2016**

**WHEREAS**, Section 11.2.6 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, or the Government Procurement Reform Act, provides for a fixed term of ONE (1) YEAR, for the members of the BAC, to wit:

"11.1.6 Unless sooner removed for a cause, the members of the BAC shall have a fixed term of one (1) year reckoned from the date of appointment, renewable at the discretion of the Head of the Procuring Entity. Upon expiration of the term of the current members, they shall continue to exercise their functions until new BAC members are designated. In case of resignation, retirement, separation, transfer, re-assignment, removal, or death, the replacement shall serve only the unexpired term: Provided, however, That in case of leave or suspension, the replacement shall serve only for the duration of the leave or suspension. For justifiable cause, a member shall be suspended or removed by the Head of the Procuring Entity."

**WHEREAS**, Executive Order No. 14, Series of 2016, which designated the latest membership of the Muntinlupa City – Bids and Awards Committee (M-BAC) and of the Ospital ng Muntinlupa – Bids and Awards Committee (OSMUN-BAC), was promulgated on 31 May 2016;

**WHEREAS**, owing to personnel movement affecting the composition of the committees, there is likewise a need to amend the composition thereof as provided in the same E.O. No. 14, Series of 2016;

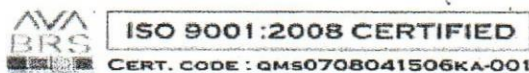
**NOW, THEREFORE, I, JAIME R. FRESNEDI**, City Mayor of Muntinlupa, by virtue of Section 11, Article V of R.A. 9184, do hereby order the amendment of the composition of the Muntinlupa City–BAC & OSMUN-BAC, their Secretariat and TWG, as provided hereunder.
