EXECUTIVE ORDER No. 24
Series of 2020

PROVIDING FOR AN AMENDMENT TO EXECUTIVE ORDER No. 23, SERIES OF 2020, ISSUED ON 26 JUNE 2020, WHICH PROVIDES FOR THE EXTENSION OF THE EXTREME LOCALIZED COMMUNITY QUARANTINE IN ZONE 3 INTERIOR, SITIO PAGKAKAISA, BARANGAY SUCAT, CITY OF MUNTINLUPA

WHEREAS, Executive Order No. 23, Series of 2020, issued on 26 June 2020, provides for the extension of the Extreme Localized Community Quarantine (ELCQ) in Zone 3 Interior, Sitio Pagkakaisa, Barangay Sucat, City of Muntinlupa. Henceforth, the period of the ELCQ was declared from 12:01 am of 13 June 2020, Saturday, to 11:59pm of 03 July 2020, Friday;

WHEREAS, the City Health Office received on 29 June 2020 the results of the Polymerase Chain Reaction (PCR) tests conducted among the residents of the above-mentioned community, which came out favorable, and, furthermore, those who needed to be isolated have been successfully subjected to in a facility for that purpose, as attested to by the following facts, namely:

WHEREAS, there exists an urgent need to review the period provided for in Executive Order No. 23, Series of 2020 in light of the positive developments in managing the contagion among the residents of the aforesaid community;

NOW, THEREFORE, I, Jaime R. Fresnedi, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Reduction of Period.

The period of the Extreme Localized Community Quarantine (ELCQ) in Zone 3 Interior, Sitio Pagkakaisa, Barangay Sucat, City of Muntinlupa shall, henceforth, be reduced, and it shall be

From 12:01am of 13 June 2020, Saturday, to 11:59pm of 29 June 2020, Monday.

Section 2. Repealing Clause.

An order or a directive that is inconsistent with any provision herein found is deemed repealed, revoked or amended accordingly.



Section 3. Separability Clause.

In the event that any provision herein found is judicially struck down as illegal or administratively declared as infirm, untouched provisions shall remain in full force and effect.

Section 4. Effectivity Clause.

This Executive Order shall take effect immediately upon its signing, and it shall remain in full force and effect unless repealed, revoked or amended accordingly.
