### EXECUTIVE ORDER No. 26 Series of 2019

### PROVIDING FOR THE CREATION OF THE COMMITTEE ON OUTSTANDING CITIZENS OF MUNTINLUPA 2019, ITS COMPOSITION AND FUNCTIONS

**WHEREAS,** Section 20 of Article II of the 1987 Philippine Constitution provides that "(t)he State recognizes the indispensable role of the private sector, encourages private enterprise, and provides incentives to needed investments;"

**WHEREAS,** Section 23, *supra*, provides that "(t)he State shall encourage non-governmental, community-based, or sectoral organizations that promote the welfare of the nation;"

WHEREAS, Section 455 (b) (1), Article I, Chapter III, Title III of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that the city mayor shall "(e)xercise general supervision and control over all programs, projects services, and activities of the city government;"

**WHEREAS,** the City Government of Muntinlupa wishes to recognize the recent remarkable achievements of its citizens through an award system based on substance and consequence and their ability to inspire, uplift and motivate;

**WHEREAS,** Executive Order No. 25, Series of 2016, was issued for the purpose of selection of Muntinlupa Achievers 2016, a process less stringent and time-consuming than the one being provided this year;

**NOW, THEREFORE, I, Jaime R. Fresnedi,** City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Creation and Composition.

The Committee on Outstanding Citizens of Muntinlupa 2019 (COCM 2019, for brevity) is hereby created, and it shall be composed of the following:

Section 2. Functions.

The COCM 2019 shall perform the following functions, namely:

Tourism, Culture and the Arts Department

- Identify and mobilize sub-groups belonging to the private and public sectors who can a. initially recognize and ascertain names of individuals for selection;
- Receive the nominated forms and undertake each nomination to careful study, and b. confirm, whenever possible and practical, all entries mentioned therein, including the achievements enumerated;

- c. Seek assistance from sources, both within or outside the City Government, for confirmation and gathering of facts, or for other acts necessary to arrive at the veracity of all facts written thereat;
- Draw a list of possible contenders for Outstanding Citizens of Muntinlupa 2019 and submit this to the City Mayor, who shall decide on the final names on the list;
- Coordinate with concerned departments and offices on all related requirements, including financial, logistical, among others; and
- f. Perform such other functions as may be necessary to achieve the foregoing.

Section 3. Selection Criteria.

In the selection process, the COCM 2019 shall be bound by the residency requirement of each nominated individual, the gravity and import of his or her achievements, and the facility of these achievements to inspire fellow Muntinlupeños, particularly the youth. Although they are not bound, the COCM 2019 may adopt the following sectors in their selection of possible contenders, namely:

- a. Culture and the Arts;
- b. Youth and Sports;
- c. Education;
- Business, particularly medium to large enterprises;
- e. Labor;
- f. Senior Citizens:
- g. Urban Poor;
- h. Public Order and Safety;
- i. Health and Medical Services;
- j. Environmental Protection:
- k. Public Service, including active and retired;
- l. Women and Family; and
- m. Persons with Disability.

Section 5. Repealing Clause

All orders, directives or memoranda inconsistent with any provision contained in this executive order are hereby revoked, repealed or amended accordingly.

Section 6. Separability Clause.

Any provision herein judicially found illegal or infirm shall not affect untouched provisions.

Section 7. Effectivity Clause.

This Executive Order shall take effect immediately upon signing, and it shall remain in full force and effect until revoked, repealed or amended accordingly.
