**EXECUTIVE ORDER No. 26**  
Series of 2020

**PROVIDING FOR THE CLOSURE OF PUREGOLD SUPERMARKET LOCATED IN AGRO HOMES, NATIONAL ROAD, BARANGAY PUTATAN, CITY OF MUNTINLUPA FOR FIFTEEN DAYS DUE TO PRESENCE OF COVID-19**

**WHEREAS**, Resolution No. 5, Series of 2020, issued by the Inter-Agency Task Force (IATF) on Emerging and Infectious Diseases, dated 25 May 2020, provides for the Requirements for LGU Appeals for Classification of LGU-Wide Community Quarantine and for LGU Declaration of Localized Community Quarantine;

**WHEREAS**, an unnumbered Regional Memorandum, issued by the Department of the Interior and Local Government (DILG), dated 25 May 2020, provides for the Requirements for LGU Appeals for Classification on LGU-Wide Community Quarantine and for LGU Declaration of Localized Community Quarantine;

**WHEREAS**, while the City Government has made three declarations of Extreme Localized Community Quarantine, those involve communities, and not a specific business establishment, unlike the situation in Puregold Supermarket, located in Agro Homes, National Road, Barangay Putatan;

**WHEREAS**, one (1) staff member thereof has tested positive for covid-19, three (3) are probable cases, awaiting confirmatory test results, seven (7) staff members experience no sense of smell and taste, a manifestation they are symptomatic;

**WHEREAS**, the City Health Office (CHO) conducted its investigation on the premises, and found out a litany of health and safety violations committed in the premises;

**WHEREAS**, the CHO, as the lead office in identifying, managing, and responding to issues on covid-19, strongly recommends the issuance of a closure order for Puregold Supermarket, Agro Homes, National Road, Barangay Putatan;

**NOW, THEREFORE, I, Jaime R. Fresnedi, City Mayor of Muntinlupa**, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Declaration.

A Closure Order is hereby declared and issued against Puregold Supermarket located in Agro Homes, National Road, Barangay Putatan, City of Muntinlupa, effective from 6pm of 03 July 2020, Friday, to 6pm of 18 July 2020, Saturday.

The City Health Office (CHO) shall monitor the situation on the ground, the condition of the staff members and enlist the help of allied local offices, such as, but not limited to, the Philippine National Police - Muntinlupa City Station, the Disaster Risk Reduction and Management Office, the Ospital ng Muntinlupa, and National Government Agencies (NGAs), as the need arises. Regular reports shall be submitted to the Office of the City Mayor.

The Business Permits and Licensing Office (BPLO) shall provide assistance in observance of all health protocols in the event of re-opening and in compliance to all regulatory impositions.


Section 2. Separability Clause.

In the event that any provision herein found is judicially struck down as illegal or administratively declared as infirm, untouched provisions shall remain in full force and effect.

Section 3. Effectivity Clause.

This Executive Order shall take effect immediately upon its signing, and it shall remain in full force and effect unless repealed, revoked or amended accordingly.
