EXECUTIVE ORDER No. 27 Series of 2016

PROVIDING FOR THE REORGANIZATION OF THE MUNTINLUPA EXPANDED UGNAYAN NG BARANGAY AT SIMBAHAN- TECHNICAL WORKING GROUP (MEUBAS-TWG)

WHEREAS, Section 23, Article II of the 1987 Philippine Constitution, provides that "(t)he State shall encourage non-governmental, community-based, or sectoral organizations that promote the welfare of the nation;"

WHEREAS, Section 3 (1) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(t)he participation of the private sector in local governance, particularly in the delivery of basic services, shall be encouraged to ensure the viability of local autonomy as an alternative strategy for sustainable development;"

WHEREAS, Section 35, *supra*, provides that "(l)ocal government units may enter into joint ventures and such other cooperative arrangements with people's and non-governmental organizations to engage in the delivery of certain basic services, capability building and livelihood projects, and to develop local enterprises deisgned to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people;"

WHEREAS, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2016-116 entitled "Implementation of the MASA MASID (Mamamayang Ayaw sa Anomalya, Mamamayang, Ayaw Sa Iligal na Droga) Program," a community-based initiative to engage volunteers in the fight against corruption, criminality and illegal drugs and to adopt a multi-sectoral and mass-based approach to ensure effective means to combat illegal drugs and drug related crimes;

WHEREAS, in the MASA MASID Program, an Expanded UBAS-Technical Working Group (TWG) shall be organized, act as the social facilitator and be responsible in convening, organizing, training and mobilizing the MASA MASID Teams in the barangays;

WHEREAS, the Expanded UBAS-TWG is chaired by the DILG City Director, with members coming from the Liga ng mga Barangay City Federation, local Philippine National Police, City Anti-Drug Abuse Council (ADAC), and members or representatives of the church and other faith-based organizations.

NOW, THEREFORE, I, Atty. JAIME R. FRESNEDI, by virtue of the powers vested in me by law, do hereby ordain and decree that:

The members of the MEUBAS-TWG shall designate his or her permanent and official alternate who shall attend for and in his or her behalf, in the event that personal appearance is not possible.

Section 2. Functions.

Primarily, the MEUBAS-TWG shall serve as the social facilitator of the MASA MASID Program. It shall manage and steer the implementation of the Program. Towards this end, its secondary functions include:

- Convene and mobilize the MASA MASID Team at the barangay level;
- b. Provide appropriate technical and administrative assistance to the program;
- c. Implement a systematic monitoring and reporting mechanism;
- d. Hold quarterly regular meeting or as the need for it arises; and
- e. Perform other related responsibilities as may be assigned by competent authorities.

Section 3. Secretariat.

The Drug Abuse Prevention and Control Office (DAPCO) shall serve as the Secretariat of the MEUBAS-TWG. It shall handle the administrative, technical activities and logistical support during the meetings of the TWG. Moreover, it shall handle the listing of all alternate individuals mentioned in Section 1.

Section 4. Separability Clause.

All executive orders, regulations, memoranda and other instruments inconsistent with any provision herein written are hereby amended or repealed accordingly.

Section 5. Effectivity.

This Executive Order shall take effect immediately.
