Series of 2017

PROVIDING FOR AMENDMENTS TO EXECUTIVE ORDER NO. 05, SERIES OF 2015,
ON THE CREATION, COMPOSITION AND FUNCTIONS OF
THE MUNTINLUPA CLIMATE CHANGE BOARD,
PARTICULARLY ON THE COMPOSITION THEREOF

WHEREAS, the Muntinlupa Climate Change Board has been institutionalized by virtue of Executive Order No. 05, Series of 2015, duly executed on 24 March 2015;

WHEREAS, the composition thereof must reflect the current situation inasmuch as many other offices are involved in the formulation of policy and implementation of plans on climate change management and mitigation;

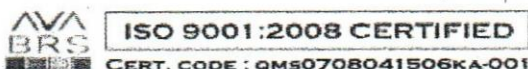
WHEREAS, all premises declared in the aforementioned Executive Order are unaffected and are reiterated herein;

NOW, THEREFORE, I, Atty. JAIME R. FRESNEDI, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby ordain and decree:
