Executive Order No. 28

**PROVIDING FOR THE DESIGNATION OF  
THE FOCAL PERSON FOR PERSONS WITH DISABILITY**

**WHEREAS**, Section 5, Rule IV of the Implementing Rules and Regulations (IRR) of Republic Act No. 10070, otherwise known as An Act Establishing an Institutional Mechanism to Ensure the Implementation of Programs and Services for Persons with Disabilities in Every Province, City and Municipality, amending Republic Act No. 7277, otherwise known as the Magna Carta for Disabled Persons, as amended, and For Other Purposes provides that "(t)he Persons with Disability Affairs Office (PDAO) shall be established in all provinces, cities, and first, second and third class municipalities under the office of the governor, city or municipal mayor, respectively. The PDAO may be a department, division or section;"

**WHEREAS**, Section 7, *supra*, provides that "(p)riority shall be given to qualified person with disabilities in the appointment of the head of PDAO for the provinces, cities, and 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> class municipalities, and the Focal Person for 4<sup>th</sup>, 5<sup>th</sup> and 6<sup>th</sup> class municipalities;"

**WHEREAS**, the draft ordinance for the creation of the Persons with Disability Office is pending for deliberation and awaiting decision of the members of the Sangguniang Panlungsod of the City of Muntinlupa;

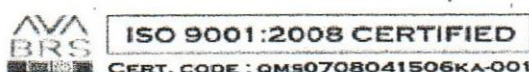
**WHEREAS**, in order to effectively carry out the expected output as mandated by law, it is necessary to designate a Focal Person while the process aforementioned is ongoing;

**WHEREAS**, the Social Services Department has long benefitted from the services rendered by Caridad G. Molo as the focal person for concerns of persons with disability in the City of Muntinlupa, and it would best serve the reason abovementioned to designate her as the Focal Person for Persons with Disability;

**NOW, THEREFORE, I, Jaime R. Fresnedi, City Mayor of Muntinlupa**, by virtue of the powers vested in me by law, do hereby decree and ordain that:

Section 1. Designation.

Caridad G. Molo, Social Welfare Officer III, is hereby designated as the Focal Person for Persons with Disability, under the Social Services Department.

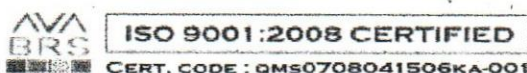

Section 2. Functions.

The Focal Person for Persons with Disability shall perform the following functions (*Section 9, Republic Act No. 10070*), namely:

- a. Formulate and implement policies, plans and programs for the promotion of the welfare of persons with disabilities in coordination with concerned national and local government agencies;
- b. Coordinate and implement the provisions of Republic Act No. 10070, Batas Pambansa Bilang 344, otherwise known as the Accessibility Law, and other relevant laws at the local level;
- c. Represent persons with disabilities in meetings of local development councils and other special bodies;
- d. Recommend and enjoin the participation of Non-Government Organizations (NGOs) and People's Organizations (POs) in the implementation of all disability-related laws and policies;
- e. Gather and compile relevant data on persons with disabilities in their localities;
- f. Disseminate information, including, but not limited to, programs and activities for persons with disabilities, statistics on persons with disabilities, including children with disability, and training and employment opportunities for persons with disabilities;
- g. Submit reports to the Office of the City Mayor on the implementation of programs and services for the promotion of the welfare of persons with disabilities are funded by both the national and local government;
- h. Ensure that policies, plans and programs for the promotion of the welfare of persons with disabilities are funded by both the national and local government;
- i. Monitor fundraising activities being conducted for the benefit of persons with disabilities;
- j. Seek donations in cash or in kind from local or foreign donors to implement an approved work plan for persons with disabilities, in accordance with existing laws and regulations;
- k. Report to and coordinate with the Social Services Department and other concerned departments and offices of the City Government the funding requirements for all programs, projects and activities for persons with disability and ensure full implementation thereof; and
- k. Perform such other functions as may be necessary for the promotion and protection of the welfare of persons with disabilities, or as may be directed by the City Mayor.
