EXECUTIVE ORDER No. 28
Series of 2020

**PROVIDING FOR THE CLOSURE OF PUREGOLD SUPERMARKET LOCATED IN
LAKEFRONT, PUROK 6, BARANGAY SUCAT, CITY OF MUNTINLUPA
FOR FIFTEEN DAYS DUE TO PRESENCE OF COVID-19**

WHEREAS, Resolution No. 5, Series of 2020, issued by the Inter-Agency Task Force (IATF) on Emerging and Infectious Diseases, dated 25 May 2020, provides for the Requirements for LGU Appeals for Classification of LGU-Wide Community Quarantine and for LGU Declaration of Localized Community Quarantine;

WHEREAS, an unnumbered Regional Memorandum, issued by the Department of the Interior and Local Government (DILG), dated 25 May 2020, provides for the Requirements for LGU Appeals for Classification on LGU-Wide Community Quarantine and for LGU Declaration of Localized Community Quarantine;

WHEREAS, the City Government of Muntinlupa, through the City Health Office, has discovered the case of a non-resident worker in Puregold Supermarket, Lakefront, Purok 6, Barangay Sucat, who was subjected to a swab test by San Miguel Corporation on 12 July 2020, found positive therefor, but continued to work thereat, despite the established protocol of subjecting himself to self-quarantine after the rapid test;

WHEREAS, because of this grave omission, upon the conduct of contact tracing, twenty-five (25) close contacts were established, and, although none has proven positive yet, the number of probable cases justifies the declaration of a Closure Order thereat;

WHEREAS, it is necessary to evaluate and impose strict quarantine guidelines on staff members, to provide mass testing for all staff members, especially for residents of the City of Muntinlupa, and for those who are not, they shall be referred to their respective local government units (LGUs), and to conduct decontamination of the premises;

WHEREAS, the CHO, as the lead office in identifying, managing, and responding to issues on covid-19, strongly recommends the issuance of a closure order for Puregold Supermarket, Lakefront, Purok 6, Barangay Sucat;

NOW, THEREFORE, I, Jaime R. Fresnedi, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Declaration.

A Closure Order is hereby declared and issued against Puregold Supermarket located in Lakefront, Purok 6, Barangay Sucat, City of Muntinlupa, effective from 6am of 13 July 2020, Monday, to 6pm of 28 July 2020, Tuesday.

The City Health Office (CHO) shall monitor the situation on the ground, the condition of the staff members and enlist the help of allied local offices, such as, but not limited to, the Philippine National Police - Muntinlupa City Station, the Disaster Risk Reduction and Management Office, the Ospital ng Muntinlupa, and National Government Agencies (NGAs), as the need arises. Regular reports shall be submitted to the Office of the City Mayor.

The Business Permits and Licensing Office (BPLO) shall provide assistance in observance of all health protocols in the event of re-opening and in compliance to all regulatory impositions.

Section 2. Separability Clause.

In the event that any provision herein found is judicially struck down as illegal or administratively declared as infirm, untouched provisions shall remain in full force and effect.

Section 3. Effectivity Clause.

This Executive Order shall take effect immediately upon its signing, and it shall remain in full force and effect unless repealed, revoked or amended accordingly.
