EXECUTIVE ORDER No. 29
Series of 2017

**PROVIDING FOR THE EXPANSION OF THE COMPOSITION AND FUNCTIONS OF
THE NEW LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN OF
THE CITY OF MUNTINLUPA,
PURSUANT TO CITY ORDINANCE NO. 17-110**

WHEREAS, Section 13 of Article II of the 1987 Constitution provides that "(t)he State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;"

WHEREAS, City Ordinance No. 17-110 provides for the establishment of a New Local Council for the Protection of Children of Muntinlupa City and creation of Inter Agency Monitoring Task Force and for other purposes, thereby repealing City Ordinance No. 02-073;

WHEREAS, Section 3, *supra*, provides that "(t)he City Mayor, through an Executive Order (EO), may expand the Local Council for the Protection of Children (LCPC) composition if deemed necessary;

WHEREAS, the task of child-friendly local governance and the vision of a child-caring city necessitates the evolution of the aforementioned Council towards an expanded composition of its members and a redefined organizational structure to better enforce its functions;

NOW, THEREFORE, I, Jaime R. Fresnedi, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby decree and order that:

Section 1. Expansion of the Council.

Further to Section 2 of City Ordinance No. 17-110, the Composition of the Local Council for the Protection of Children (Council, *for brevity*) is expanded, and shall be broken into four (4) partitions, namely: The Executive Committee, the Technical Management Committee, The Secretariat, and the Inter-Agency Monitoring Task Force.

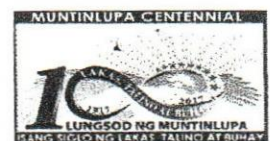

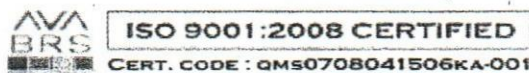

Section 2.B. Functions.

- a. Devise plans and implement these into programs and policies of the Council, through the passage of a Resolution;
- b. Recommend to and, whenever necessary, submit policy directives to departments and offices of the City Government, through the issuance of memoranda or order, duly signed by the City Mayor, for proper action;
- c. Enforce and implement the provisions contained in Section 5 of City Ordinance No. 17-110;
- d. Conduct the regular meeting of the Execom once every two (2) months. The City Mayor, through the Co-Chairperson, may call for a special meeting, if necessary;

Section 3.B. Functions.

- Convene all members and conduct regular monthly meeting to discuss resolutions, position papers, and proposed programs, and recommend and submit these to the Execom;
- Conduct a special meeting, if necessary;
- Conduct meetings per cluster to facilitate policy, plan and program formulation;
- Monitor and evaluate program implementation of member-departments and offices per cluster;
- Perform such other functions as may be necessary to implement the foregoing or as provided for by law.

Section 4.B. Functions.

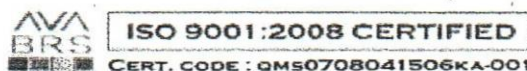
The Council Secretariat shall perform the following functions, namely:

- Coordinate the formulation and implementation of plans, programs, and policies of the Execom and the TMC;
- Mobilize resources, including those of City Government departments and offices, of individuals and instrumentalities, whether public or private, among others, and channel these resources, whenever allowed by law, to the needs of the Council;
- Introduce new, innovative and engaging pilot programs and services to the Execom and the TMC;
- Act as knowledge base and provide technical assistance to the Sangguniang Panlungsod and the Sangguniang Pambarangay, as the case may be, in legislative matters;
- Issue notices of meetings; provide logistical support in the conduct of meetings, whether regular or special; write, file and send correspondence; and keep records updated;
- Perform such other functions as may be necessary to implement the foregoing or as provided for by law.

Section 5. The Inter-Agency Monitoring Task Force.

Section 5.B. Functions.

The Task Force shall perform the following functions, namely:

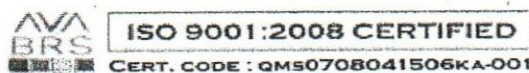
- Monitor the operating functionality of the Barangay Council for the Protection of Children, through the conduct of the Annual Assessment using the evaluation tools and procedures in accordance to DILG Memorandum Circular No. 2008-126;
- Ensure compliance of all implementing departments and offices on standards and policies set forth;
- Perform such other functions as may be necessary to implement the foregoing or as provided for by law.

Section 6. Succession.

In the event of resignation, cessation of employment, transfer, incapacity or similarly situated circumstance of an official or employee above-named, the successor thereof shall assume membership in the vacant position, without need for the issuance of another instrument or order. However, the City Mayor, upon consultation with the City Administrator and Head of the Social Services Department, may appoint another person to assume membership thereto.

Section 7. Allowance.

Following Section 9, *supra*, "permanent and expanded members of the Council shall be entitled to at least One Thousand (Php 1,000.00) Pesos allowance for every meeting attended, subject to the usual accounting and auditing laws, rules and regulations."

Section 8. Separability Clause.

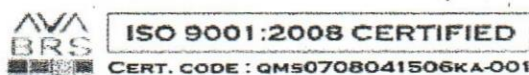
Any provision in this Executive Order found unsound, illegal or infirm shall be stricken off and made ineffective. Those untouched provisions shall remain in full force and effect.

Section 9. Effectivity Clause.

This Executive Order shall take effect immediately upon signing, and shall remain in full force and effect until revoked, rescinded, amended or superseded accordingly.
