EXECUTIVE ORDER No. 30
Series of 2017

PROVIDING FOR THE ENUMERATION OF SELECT PERSONNEL OF THE
CITY GOVERNMENT OF MUNTINLUPA, AND THEIR DEPUTIZATION,
IN THE IMPLEMENTATION AND ENFORCEMENT OF
CITY ORDINANCE NO. 072, SERIES OF 2017

WHEREAS, City Ordinance No. 072, Series of 2017, provides for the prohibition on the use, sale, distribution, and advertisement of cigarettes, and other tobacco products and electronic cigarettes, in certain places, imposing penalties thereof, providing funds therefor;"

WHEREAS, the City Health Office (CHO), as lead agency, is mandated to enforce and implement the provisions of the aforementioned ordinance. However, CHO personnel lacks the sufficient number to be truly effective implementers and enforcers thereof, hence, the necessity to involve other employees of the City Government of Muntinlupa;"

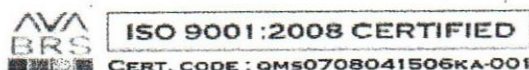
WHEREAS, the involvement of qualified and competent personnel of the City Government of Muntinlupa, as well as of the Barangay Governments, in this endeavor manifests their commitment to see the successful implementation and enforcement of the said city ordinance;"

NOW, THEREFORE, I, Jaime R. Fresnedi, City of Muntinlupa, by virtue of the powers vested in me by law, do hereby decree and order that:

Section 1. Deputization.

The following personnel of the City Government of Muntinlupa (CGM, *for brevity*) and Barangay Governments, as indicated, are hereby deputized to implement and enforce the provisions of City Ordinance No. 072, Series of 2017, namely:

In the event of resignation, transfer, cessation of employment, incapacity, or other similarly-situated circumstance, the above-named City Government employee or Barangay Government official or personnel shall lose his or her deputization. The City Health Office shall strike off the said name from this list, and it shall duly inform the City Human Resources Management Department.

Section 2. Functions.

All individuals named in the preceding section shall perform the following functions, namely:

- a. Identify, apprehend and issue a citation ticket to any violator of City Ordinance No. 17-072, at any time, within the territorial jurisdiction of the City of Muntinlupa;
- b. Inspect and monitor establishments as provided in City Ordinance No. 17-072;
- c. Ensure the widest possible dissemination among all stakeholders, in coordination with the City Health Office, on the contents, provisions and penalties outlined in City Ordinance No. 17-072;
- d. Submit a written report to the City Smoke Free Task Force on any untoward enforcement incident for proper action;
- e. Perform other functions as may be directed by the City Smoke Free Task Force or unequivocally by the City Mayor.

Section 3. Documentation.

The City Health Office shall issue each above-named individual a valid identification card wherein the grant and scope of authority are clearly written.

Moreover, a specific hotline and a particularly identified employee of the City Health Office shall likewise be written in the identification card to afford the violator the opportunity redress in case the individual violator or the establishment wishes to contest the apprehension and issuance of citation ticket.
