EXECUTIVE ORDER No. 30
Series of 2018

PROVIDING FOR THE ADOPTION OF THE POLICY OF PATRONIZING NON-SMOKING VENUES FOR SEMINARS, CONFERENCES, TRAINING VENUES, LECTURES, FORUMS, MEETINGS, ACTIVITIES, AND SIMILARLY-SITUATED GATHERINGS FOR DEPARTMENTS AND OFFICES OF THE CITY GOVERNMENT

WHEREAS, Executive Order No. 26, signed by President Rodrigo Roa Duterte, and dated 16 May 2017, provides for prohibition on smoking in public places, and enumerates public areas covered by such ban;

WHEREAS, Muntinlupa City Ordinance No. 17-072 provides for a more stringent enforcement of the provisions of the aforementioned Executive Order, including prohibition on vapes and electronic cigarettes, in public places, transport vehicles, among others within the jurisdiction of the City of Muntinlupa;

WHEREAS, the Office of the City Administrator issued a Memo, signed by City Administrator Engr. Allan A. Cachuela, and dated 22 December 2017, wherein all departments and offices of the City Government shall patronize non-smoking venues for seminars, conferences, training venues, meetings, and similarly-situated gatherings;

NOW, THEREFORE, I, Jaime R. Fresnedi, City Mayor, by virtue of the powers vested in me by law do hereby decree and order that:

Section 1. Adoption of Policy.

The Departments and Offices of the City Government of Muntinlupa, including National Government Agencies operating within the City of Muntinlupa, whenever applicable, shall adopt the following policy, namely:

Patronize the services of any hotel, resort, restaurant, entertainment venue, or any similarly-situated establishment that promotes smoke-free environments for purposes of conducting any seminar, conference, training, lecture, forum, meeting, activity, or any similarly-situated gathering, in pursuit of its mandate or in the performance of its functions;

Section 2. Necessary Coordination.

The City Health Office, in coordination with the Business Permits and Licensing Office, shall produce a list of smoke-free establishments for the easy reference and convenience of all departments and offices not later than thirty (30) days from the signing of this Executive Order. This list shall be made readily available for all related concerns.

Section 3. Repealing Clause.

Any order, memorandum, or similarly-written directive inconsistent with any provision found herein shall be deemed repealed, revoked, amended or superseded accordingly.


Section 4. Separability Clause.

Any provision found herein judicially declared unlawful or infirm shall be deemed stricken off, and untouched provisions shall remain in full force and effect.

Section 5. Effectivity Clause.

This Executive Order shall take effect immediately upon its signing.
