EXECUTIVE ORDER No. 32
Series of 2018

PROVIDING FOR THE CREATION OF THE CITY OF MUNTINLUPA
DRINKING WATER QUALITY MONITORING COMMITTEE,
ITS COMPOSITION AND FUNCTIONS

WHEREAS, Section 9 of Presidential Decree No. 856 provides that "(s)tandards for drinking water and their bacteriological and chemical examinations, together with the evaluation of results, shall conform to the criteria set by the National Drinking Water Standards. The treatment of water to render it safe for drinking, and the disinfection of contaminated water sources together with their distribution systems shall be in accordance with procedures prescribed by the Department (of Health);"

WHEREAS, Section 17 (a) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "(l)ocal government units shall likewise exercise such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities enumerated herein," and Section (b) (2) (i), *supra*, provides that included in these basic services and facilities are "water and soil resources utilization and conservation projects," and Section (b) (2) (vi), *supra*, provides, likewise, "(s)olid waste disposal system or environmental management system and services or facilities related to general hygiene and sanitation, which, although granted to a municipality, are nonetheless applicable to a highly urbanized city, like the City of Muntinlupa, pursuant to Section 17 (4), *supra*;

WHEREAS, recent developments in the security and availability of adequate and safe drinking water resources for the residents of Muntinlupa necessitate the creation of a committee whose primary function is to safeguard the foregoing;

NOW, THEREFORE, I, Jaime R. Fresnedi, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Creation and Composition.

Membership in the Water Quality Committee is a function of the office to which the individual belongs. Hence, the resignation, removal, transfer, incapacity, death, or similarly-situated circumstance of the individual concerned shall entitle the successor to assume membership thereto without the need for the issuance of another order or instrument.

Section 2. Functions.

The Water Quality Committee shall perform the following functions, namely:

- (a) Receive reports, collect data and solicit information from all available and related sources on the quality of drinking water made available for the residents of Muntinlupa;
- (b) Conduct regular, or sudden, whenever necessary, inspections on sources of drinking water at source, whenever practicable;
- (c) Study possible or existing occurrences of contamination, and submit to proper authorities the recommendations for immediate resolution of the problem;
- (d) Study measures and proposals to address problems connected with ensuring the quality of drinking water available, and recommend solutions to address supply issues;
- (e) Perform such other functions as may be directed by competent authority, or as may be necessary to achieve the foregoing.

Section 3. Secretariat.

The Secretariat of the Water Quality Committee shall be composed of Messrs. Edgardo O. Argana III, Norberto C. Duran, Jr., and Kenneth Paul A. de la Cruz. They shall be responsible for the issuance of Notice of Meetings; logistical support for meetings; writing down, filing and dissemination of Minutes of Meeting; writing down, recording and receiving correspondence; and similarly-situated functions.

Section 4. Funding.

All expenses related to the operation and administration of the Water Quality Committee shall be sourced from the City Health Office Annual Budget.

Section 5. Separability Clause.

If any provision herein is found illegal or infirm, untouched provisions shall remain in full force and effect.


Section 6. Repealing Clause.

Any order or directive found inconsistent with any provision herein shall be deemed revoked, repealed, rescinded or amended accordingly.

Section 7. Effectivity Clause.

This Executive Order shall take effect immediately upon signing, and it shall be in full force and effect until revoked, repealed, rescinded or amended accordingly.
