EXECUTIVE ORDER No. 35
Series of 2020

**PROVIDING FOR FURTHER AMENDMENTS TO EXECUTIVE ORDER NO. 24,
SERIES OF 2016, ON THE MATTER OF THE RECOMPOSITION OF
THE COMMITTEE ON TERRITORIAL BOUNDARIES**

WHEREAS, Executive Order No. 7, Series of 2014, provides for the Creation of a Committee on Territorial Boundaries, which shall perform the following duties and functions, to wit: review and compilation of available legal document/s defining the area and territory of the City of Muntinlupa, by metes and bounds or natural boundaries; conduct of geodetic survey to determine possible encroachments by neighboring cities of these identified and established territorial boundaries; and recommend the institution of the appropriate actions to assert and enforce the City of Muntinlupa's territorial boundaries to the City Mayor;

WHEREAS, due to personnel movement/transfer or change in work assignment brought about by exigencies of service, as well as the need to include representation from other pertinent departments/offices, the composition of the Committee has since undergone changes, through the issuance of the amendatory Executive Order No. 24, Series of 2016 and Executive Orders No. 18 and 30, respectively, Series of 2014;

WHEREAS, there is a need to further amend or modify the composition of the Committee to reflect the present holders of various positions in the City, as provided hereunder;

NOW, THEREFORE, I, Jaime R. Fresnedi, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Recomposition.

The Committee on Territorial Boundaries (Committee, *for brevity*) is hereby recomposed and shall hereinafter have for its members the following individuals with their respective designations, namely:

Membership among public officials and officers in the Committee is a function of their respective offices. As such, the resignation, removal, termination, death, incapacity, or similarly-situated circumstance of the public official or officer shall entitle the successor thereof to assume membership, without need for issuance of another order or instrument.

Membership outside the public service shall be in accordance with the civic duty of the concerned private individual. They are, however, bound by the same standards of fidelity, honesty and integrity whilst in the service of the Committee.

Section 2. Secretariat.

Arch. May L. Santiago, City Planning and Development Office, shall be the Secretary of the Committee and shall perform all functions requisite thereof.

Section 3. Allowance.

Members of the Committee, together with the Secretary, shall receive the amount of One Thousand (Php1,000.00) Pesos for every meeting duly attended, subject to submission of duly attested attendance record and to availability of funds.

Section 4. Repealing Clause.

Any order or directive inconsistent with the foregoing is hereby repealed, revoked, or amended accordingly.

Section 5. Separability Clause.

If any provision found herein is judicially declared illegal or administratively struck down infirm, untouched provisions shall continue to be in full force and effect.

Section 6. Effectivity Clause.

This Executive Order shall take effect immediately, and it shall remain in full force and effect unless repealed, revoked, or amended accordingly.


