**PROVIDING FOR AMENDMENTS TO EXECUTIVE ORDER NO. 12, SERIES OF 2016,
AND EXECUTIVE ORDER NO. 11, SERIES OF 2017,
ON THE CREATION OF THE MONITORING AND EVALUATION TEAM FOR THE
IMPLEMENTATION OF THE MAGNA CARTA OF WOMEN IN THE CITY OF MUNTINLUPA**

WHEREAS, Executive Order No. 12, Series of 2016, provided for the creation of a Monitoring and Evaluation Team for the Implementation of the Magna Carta of Women in the City of Muntinlupa;

WHEREAS, Executive Order No. 11, Series of 2017, provided for amendments to Executive Order No. 12, Series of 2016, for the period of 2016-2019;

WHEREAS, rules of competent authority require the issuance of another Executive Order covering the same subject matter for the period 2022 to 2025, representing the new term of the incumbent undersigned;

NOW, THEREFORE, I, Rozzano Rufino B. Biazon, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Re-Creation and Re-Composition.

The Monitoring and Evaluation Team of the City of Muntinlupa (*METCM, for brevity*), for the implementation of Republic Act No. 9710, otherwise known as the Magna Carta of Women, is hereby re-created. It shall be re-composed of the following individuals, namely:

Section 2. Functions.

The METCM shall perform the following functions, namely:

- (a) Establish a Monitoring and Evaluation System for the proper implementation of Republic Act No. 9710;
- (b) Monitor the implementation of the Annual Gender and Development (GAD) Plan and the utilization of the GAD Budget, and assess the status of the City Government's institutional mechanisms on gender mainstreaming annually;
- (c) Evaluate the outcomes of the City Government's GAD policies, programs, and projects, and submit a GAD Evaluation Report to the DILG Regional Office at the end of the Local Chief Executive's three-year term. The submission shall be done not later than June of the next term;
- (d) Perform such other functions as may be directed by competent authority, or as may be necessary to achieve the foregoing.

Section 3. Meetings and the Secretariat.

The MEBTC shall meet once every month, or as often as necessary if warranted.

The GAD staff members shall be responsible for the smooth and orderly conduct of the meeting, issuance of Notice of Meeting; logistical requirements; taking down, disseminating and filing of Minutes of Meeting; writing, disseminating and filing correspondences; handling administrative requirements; among others.

Section 4. Quorum.

A majority of the members of the MEBTC shall be sufficient to constitute a quorum for the conduct of official business in the meeting.

Section 5. Repealing Clause.

Previously issued orders inconsistent with any provision found herein shall be deemed repealed, revoked, or amended accordingly.

Section 6. Separability Clause.

In the event any provision found herein is judicially decided illegal or administratively held infirm, untouched provisions shall continue to remain in full force and effect.

Section 7. Effectivity Clause.

This Executive Order shall take effect upon its signing, and it shall remain in full force and effect until repealed, revoked, or amended accordingly.
