EXECUTIVE ORDER No. 2 Series of 2022-B

PROVIDING FOR THE RE-ORGANIZATION OF THE EXECUTIVE COMMITTEE, THEREBY AMENDING EXECUTIVE ORDER NO. 01, SERIES OF 2013, ITS COMPOSITION AND FUNCTIONS

WHEREAS, Executive Order No. 01, Series of 2013, issued on 24 July 2013, was issued providing for the organization, composition and functions of the Executive Committee, which shall primarily be involved in the formulation and development of plans, programs, and projects to address the social and economic well-being of the inhabitants of the City of Muntinlupa, and in the recommendation of all these to the Office of the City Mayor;

WHEREAS, the change in the administration, following the conduct of the National and Local Elections held on 09 May 2022, necessitates the re-organization of the Executive Committee to reflect changes in the composition thereof;

NOW, THEREFORE, *I, Rozzano Rufino B. Biazon, City Mayor of Muntinlupa,* by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Re-organization of the Executive Committee.

The Executive Committee of the City Government of Muntinlupa (Execom, for brevity) is hereby re-organized, and it shall be composed of the following individuals, with their respective designations, namely:

Section 2. Functions.

The Execom shall perform the following functions, namely:

- Formulate and develop plans, programs and projects that shall best serve the interests of the inhabitants of the City of Muntinlupa, and recommend the same to the Office of the City Mayor for appropriate action and implementation;
- Introduce amendments to existing plans, programs and projects that may already be in place, and consolidate inputs to put forth the best possible outcome;
- Monitor plans, programs and projects already in the implementation stage, and ensure their full implementation and resolution;
- Assist in efforts to ensure harmonious and productive working relationship among (d) all employees, including officers, of the City Government, national government agencies, non-governmental organizations, civil society groups, private sector, and other concerned stakeholders;
- Perform such other functions as may be necessary to accomplish the foregoing, and (e) as may be directed by competent authority.

Section 3. Honorarium.

Subject to sound accounting rules and to limitations set forth by law, members of the Execom shall each receive the amount of Three Thousand (Php 3,000.00) Pesos every month.

Section 4. Repealing Clause.

All previously issued orders and directive contrary to provisions herein found shall be deemed repealed, revoked or amended accordingly.

Section 5.

Separability Clause.

In the event any provision herein found shall be judicially decided illegal or administratively declared infirm, untouched provisions shall continue to have full force and effect.

Section 6.

Effectivity Clause.

This Executive Order shall take effect immediately, and it shall remain in full force and effect until repealed, revoked or amended accordingly.
