EXECUTIVE ORDER No. 36
Series of 2022

**PROVIDING FOR AMENDMENTS TO EXECUTIVE ORDER NO. 02, SERIES OF 2019, ON
THE CREATION OF THE ENHANCED COMPREHENSIVE LOCAL INTEGRATION
PROGRAM (ECLIP) COMMITTEE OF THE CITY OF MUNTINTUPA,
ITS COMPOSITION AND FUNCTIONS**

WHEREAS, Section 5 of Article II of the 1987 Philippine Constitution provides that "*(t)he maintenance of peace and order, the protection of life, liberty and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy;*"

WHEREAS, Section 17 (3) (v) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the services of a province include "*(s)ocial welfare services which include programs and projects on rebel returnees and evacuees; relief operations; and, population development services;*" furthermore, Section 17 (4), *supra*, provides that "*(a)ll the services and facilities of the municipality and province*" are likewise to be provided by the city;"

WHEREAS, Executive Order No. 03, Series of 2001, calls for the pursuit of a comprehensive, integrated and holistic peace process to address the internal armed conflicts and the root causes involving, among others, the implementation of the programs to address the legal status and security of former rebels, as well as community-based assistance to respond to their economic, social and psychological rehabilitation needs;

WHEREAS, the Department of the Interior and Local Government (DILG) and the Office of the Presidential Adviser on Peace Process (OPAPP) issued Joint Memorandum Circular No. 2014-01, which provides guidelines for the implementation of the Comprehensive Local Integration Program (CLIP) for former New People's Army (NPA) rebels;

WHEREAS, to further enhance the CLIP Program, Administrative Order No. 10 of the President of the Philippines was issued on April 2018 ordering the enhancement of the CLIP to provide a complete package of assistance to former rebels;

WHEREAS, the Department of National Defense and the Department of the Interior and Local Government issued Joint Memorandum Circular No. 2018-01, which directs all LGUs

to create an E-CLIP Committee and to steer the implementation of the E-CLIP Program at the local level, among other requirements;

WHEREAS, there is a need to enhance the existing Comprehensive Local Integration Program (CLIP) Committee of the City of Muntinlupa, created by virtue of Executive Order No. 06, Series of 2015, to comply with new directives and issuances from the National Government;

WHEREAS, in order ensure the effective and efficient implementation of ECLIP and in deference to the newly elected officials, there is a need to reorganize the ECLIP Committee of the City of Muntinlupa replacing the ECLIP Committee of the City of Muntinlupa created by virtue of Executive Order No. 02, Series of 2019;

NOW, THEREFORE, I, Rozzano Rufino B. Biazon, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby ordain and decree that:

Section 1. Reorganization and Re-composition.

The Enhanced Comprehensive Local Integration Program (E-CLIP, *for brevity*) Committee of the City of Muntinlupa is hereby reorganized. It shall be composed of the following individuals, with their respective designations, namely:

In case of resignation, removal, termination, transfer, grave illness, severe incapacity, death or any other similarly-situated circumstance of any of the public officials named above, the successor thereof shall automatically assume membership in the E-CLIP Committee without need for the issuance of another order or instrument. In the case of a private individual, the City Mayor, in consultation with all the members thereof, shall make the appointment of the successor.

Section 2. Functions.

- a. Ensure the convergence effort in the delivery of the identified services of the program including reproduction and dissemination of ECLIP Information, Education, and Communication (IEC) materials;
- b. Ensure proper documentation, including profiling, and referral of the needs of former rebels (FRs) to appropriate agencies and partner institutions including profiling of the FRs and former violent extremists (FVEs);
- c. Assist the former rebels in completing the E-CLIP Enrolment Form. The FRs and FVEs should either sign or thumb mark the Form after completing it, attested by the DILG City Director and approved by the City Mayor or by his designated officer;
- d. Assist the FRs and FVEs in the preparation and implementation of his/her Former Rebel Re-Integration Plan (FRRP)/ Former Violent Extremist Reintegration Plan (FVERP) and Business Plan (*Mungkahing Proyekto*) through the Social Services Department, as the lead agency. It shall have the option to come-up with its customized template (form) of FRRP/FVERP and Business Plan, provided that the minimum datasets reflected in the attached form is complied with;
- e. Conduct regular ECLIP Committee meeting to discuss coordination and monitoring initiatives on ECLIP implementation, and resolve issues and concerns affecting the same, which shall form part of the report to the City Peace and Order Council (CPOC) during its meeting;
- f. Facilitate the processing of FRs' and FVEs' birth certificates, identification (ID) cards/documents, registration to the Philippines Health Insurance Corporation (PHIC) and other necessary documents needed by the partner-stakeholders; and
- g. Coordinate and report to the Department of Justice (DOJ), through the Local/RPOC and Local/Regional Task Force to End Local Communist Armed Conflict (L/RTFs-ELCAC), the FRs and FVEs who will signify to avail the Amnesty Program, subject to existing laws and policies.

Section 3. Secretariat.

The Secretariat shall be composed of staff members of the DILG Muntinlupa Field Office. They shall be responsible for the issuances of notices of meetings; preparation of venues of meetings, including logistical support; taking down, dissemination and filing of minutes of meetings; correspondence; and other allied functions.

Section 4. Meetings.

The E-CLIP Committee shall meet at least twice a year. A special meeting, whenever warranted, may be called for. The agenda shall touch on plans, updates, resolution of issues and concerns, and other matters related to the faithful implementation of the E-CLIP in the City of Muntinlupa.

Section 5. Repealing Clause.

Any provision of an order, memorandum, directive or similarly-situated issuance, issued in the past, that is inconsistent with any provision of this Executive Order shall be deemed repealed, revoked, or amended accordingly.


Section 6. Separability Clause.

In the event any provision found herein shall be judicially decided illegal or administratively declared infirm, untouched provisions shall continue to be in full force and effect.

Section 6. Effectivity Clause.

This Executive Order shall immediately take effect upon its signing, and it shall remain in full force and effect until repealed, revoked, or amended accordingly.
