EXECUTIVE ORDER No. 38
Series of 2022-B

**PROVIDING FOR AMENDMENTS TO EXECUTIVE ORDER NO. 17, SERIES OF 2017,
ON THE RECREATION AND RE-COMPOSITION OF THE SMOKE-FREE TASK FORCE,
AND ITS FUNCTIONS**

WHEREAS, Executive Order No. 17, Series of 2017, dated 23 August 2017, was issued pursuant to City Ordinance No. 17-072, enacted on 06 March 2017, on the prohibition on the use, sale, distribution and advertisement of cigarettes and tobacco products, and electronic cigarettes in identified public areas;

WHEREAS, City Ordinance No. 2020-051, enacted on 27 January 2020, provided for amendments to City Ordinance No. 17-072;

WHEREAS, there is a need to introduce amendments to the aforementioned Executive Order, inasmuch as certain members are no longer occupying the positions in offices for which they were included and the inclusion of new members is imperative;

WHEREAS, the scope, effectivity and relevance of the Smoke-Free Task Force, since its inception, has remained, and all efforts to maintain these should be upheld;

NOW, THEREFORE, I, Rozzano Rufino B. Biazon, City Mayor of Muntinlupa, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Recreation and Re-Composition.

The Smoke-Free Task Force (SFTF, *for brevity*) of the City of Muntinlupa is hereby recreated, and it shall be re-composed of the following individuals, with their respective designations, namely:

Membership of the members of the SFTF is a function of the office each individual occupies. Henceforth, the removal, resignation, termination, transfer, grave illness, severe incapacity, death, or any other similarly-situated circumstance of the individual shall entitle the successor to assume membership thereto without the need for issuance of another order.

Section 2. Functions.

Pursuant to Section 12 of City Ordinance No. 17-072, the functions of the SFTF include the following, namely:

- a. Receive, review, and process reports of violations and complaints;
- b. Prepare and submit to the Office of the City Mayor, the Sangguniang Panlungsod, or any other authority appropriate measures to carry out and fully implement relevant laws, rules and regulations;
- c. Coordinate with appropriate national government agencies (NGAs), and other departments and offices of the City Government;
- d. Attend regular meetings;
- e. Deputize enforcers, for a more thorough implementation of the provisions thereof, as defined in Sections 13, 14, 15 and 16, *supra*; and
- f. Perform such other functions as may be directed by competent authority and as may be necessary to achieve the foregoing.

In addition, individual duties and responsibilities of each aforementioned member of the SFTF shall be properly observed as prescribed thereunder.

Section 3. Secretariat.

The Secretariat of the SFTF shall be composed of the following individuals from the City Health Office, with their respective designations, namely:

Any order or similar directive inconsistent with any provision herein found shall be deemed repealed, revoked, or amended accordingly.


Section 5. Separability Clause.

Section 5. Effectivity Clause.

This Executive Order shall be effective upon signing, and it shall remain in full force and effect until repealed, revoked, or amended accordingly.
