EXECUTIVE ORDER No. 47 Series of 2022-B

PROVIDING FOR AMENDMENTS TO
EXECUTIVE ORDER NO. 09, SERIES OF 2019,
EXECUTIVE ORDER No. 17, SERIES OF 2016,
EXECUTIVE ORDER No. 9, SERIES OF 2013,
ON THE REORGANIZATION, RE-COMPOSITION OF THE
ANTI-GRAFT BOARD OF THE CITY GOVERNMENT OF MUNTINLUPA

WHEREAS, under Circular No. 87-02 of the then Ministry of Local Government, by virtue of which the Anti-Graft Board was created, "All Governors, City and Municipal Mayors are directed to give special and particular attention to the creation of the aforementioned Anti-Graft Board;"

WHEREAS, Executive Order No. 9, Series of 2013, was issued on the 30th day of September 2013 providing for the reorganization and institutionalization of the Anti-Graft Board of the City of Muntinlupa, Its Composition and Functions;

WHEREAS, in line with the present administration's aggressive stance against graft and corruption, the Anti-Graft Board has even more intensified its campaign;

WHEREAS, Executive Order No. 17, Series of 2016 and Executive Order No. 09, Series of 2019 were issued, providing for amendments to Executive Order No. 9, Series of 2013;

WHEREAS, recent developments necessitate the issuance of another Executive Order providing further amendments thereto, including the definition of the functions of the Anti-Graft Board;

NOW, THEREFORE, *I, Rozzano Rufino B. Biazon, City Mayor of Muntinlupa*, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1. Reorganization and Re-composition.

The Anti-Graft Board of the City Government of Muntinlupa is hereby reorganized, and it shall be composed of the following individuals with their corresponding designations, namely:

Section 2. Functions.

Bishop Loreto P. Colcol

The Anti-Graft Board (AGB, for brevity) of the City Government of Muntinlupa (CGM) shall ensure that all officials, staff members and employees thereof shall conduct themselves with utmost regard and observance of transparency, accountability, and integrity. It shall act upon all complaints brought before its attention, and subject to rules, shall act and decide on the matter within the reglementary period. All decisions shall be in writing.

In addition, the AGB shall, from hereon, act on complaints brought before it on matters that involve elected officials of the City of Muntinlupa, including the Vice Mayor, the Members of the Sangguniang Panlungsod, the Punong Barangay, and the Members of the Sangguniang Barangay.

After due process, it shall submit its recommendation to the Office of the City Mayor, who shall transmit, if necessary, to the appropriate authorities for proper disposition and decision.

Section 3. Honoraria.

Subject to sound and relevant accounting and budgetary rules and regulations, the Chairman shall be entitled to Five Thousand (Php5,000.00) Pesos per meeting/session, while each Member shall draw Four Thousand (Php4,000.00) Pesos per meeting/session; Provided, that the number of meetings shall not exceed four (4) per month.

Section 3. Repealing Clause.

Any order or directive inconsistent with this Executive Order shall be deemed repealed, revoked, or amended accordingly.
