



## EXECUTIVE ORDER No. 10 Series of 2021

PROVIDING FOR DECLARATION OF EXTREME LOCALIZED COMMUNITY QUARANTINE IN FRESNEDI COMPOUND, AMPARO STREET, BARANGAY POBLACION, AND IN SAINT ANTHONY STREET, JPA SUBDIVISION, BARANGAY TUNASAN, CITY OF MUNTINLUPA, AND FOR THE PARAMETERS OF CONCERNED DEPARTMENTS AND OFFICES IN THE ENFORCEMENT THEREOF

WHEREAS, Resolution No. 5, Series of 2020, issued by the Inter-Agency Task Force (IATF) on Emerging and Infectious Diseases, dated 25 May 2020, provides for the Requirements for LGU Appeals for Classification of LGU-Wide Community Quarantine and for LGU Declaration of Localized Community Quarantine;

WHEREAS, an unnumbered Regional Memorandum, issued by the Department of the Interior and Local Government (DILG), dated 25 May 2020, provides for the Requirements for LGU Appeals for Classification on LGU-Wide Community Quarantine and for LGU Declaration of Localized Community Quarantine;

WHEREAS, on 25 March 2021, the City Health Office (CHO), through Juancho H. Bunyi, MD, Acting Head, recommends the imposition of Extreme Localized Community Quarantine (ELCQ) covering the Fresnedi Compound in Amparo Street, Barangay Poblacion, of 175 individuals in 48 households, reporting a high attack rate from 16 to 25 March 2021 of 17.14 per 1,000 individual population and a narrow case doubling time of 3.0 days. Moreover, the community has high population of senior citizens, has become lax in wearing face masks, and has registered clustering of cases;

**WHEREAS,** on 25 March 2021, similarly, the CHO recommends the imposition of ELCQ covering Saint Anthony Street, JPA Subdivision, Barangay Tunasan, of 155 individuals in 31 households, reporting a high attack rate of 17.14 per 1,000 population and a narrow case doubling time of 31 per 1,000 population. Additionally, the community has high population of senior citizens, and has registered clustering of cases;

**WHEREAS,** the City Health Office, as the lead office, strongly recommends the issuance of an Extreme Localized Community Quarantine over the two (2) areas above-mentioned;

**NOW, THEREFORE,** *I, Jaime R. Fresnedi, City Mayor of Muntinlupa*, by virtue of the powers vested in me by law, do hereby order and decree that:

Section 1.

Declaration.

An Extreme Localized Community Quarantine (ELCQ) is hereby declared over the following communities, namely:

- (a) Fresnedi Compound, Amparo Street, Barangay Poblacion; and
- (b) Saint Anthony Street, JPA Subdivision, Barangay Tunasan;

and this shall be effective from 6am of 26 March 2021, Friday, to 6am of 10 April 2021, Saturday, compliant with the guideline that any localized lockdown shall not be less than fifteen (15) days. This may be cut to an earlier date should conditions be ideal for such a declaration.

Section 2.

Functions.

In order to ensure the successful containment of the corona virus among the residents of the two (2) communities above-mentioned, the following offices shall perform the functions enumerated below:

## A. Philippine National Police – Muntinlupa City Station

Provide round the clock and overall security of the residents and personnel assigned and ensure peace and order.

### B. City Health Office

Provide the Polymerase Chain Reaction (PCR) testing kits and concerned personnel to conduct the same among the residents and other concerned individuals; ensure that the results thereof are properly handled; provide all logistical support for the general well-being and health of all residents.

## C. Ospital ng Muntinlupa

Provide the tertiary medical care, when warranted, and the isolation units, as deemed necessary.

## D. Department of Disaster Resilience Management

Provide the logistical requirements of all departments and offices operating in the ELCQ.

## E. Social Services Department

Provide relief food packs, which shall be forwarded to the concerned Barangay, who in turn shall be responsible for distribution to the affected individuals and households.

## F. City Planning and Development Office

Provide relevant, timely and necessary data to assist the work done by all concerned departments and offices.

### G. Public Information Office

Facilitate the dissemination of relevant, correct and necessary information to concerned offices of the City Government, including the Sangguniang Panlungsod, and agencies of the National Government; release press briefings and update proper media channels on the developments in the enforcement of the ELCQ.

### H. Environmental Sanitation Center.

Ensure compliance to environmental laws in the implementation of the quarantine, the cleanliness of the surroundings, and proper disposal of waste generated.

I. Department of the Interior and Local Government –
 Muntinlupa City Local Operations Office

Ensure that all concerned departments and offices comply to the requirements set forth by the Regional IATF on declaration of ELCQ.

### J. Barangay Governments of Poblacion and Tunasan

Provide support in terms of law enforcement and peace and order, especially considering the density of the human population in the area, of distribution of relief food packs, of provision of medical supplies and personnel, and in other areas where assistance is needed.

Section 3. Separability Clause.

In the event that any provision herein found is judicially struck down as illegal or administratively declared as infirm, untouched provisions shall remain in full force and effect.
