### EXECUTIVE ORDER No. 21 Series of 2021

#### PROVIDING FOR THE CREATION OF LOCAL INTER-AGENCY TASK FORCE AGAINST DELTA VARIANT IN THE CITY OF MUNTINLUPA, ITS COMPOSITION AND FUNCTIONS

WHEREAS, on July 22, 2021 the Inter-Agency Task Force for the Management of Emerging Infectious Diseases issued Resolution No. 128, Series of 2021, to further prevent introduction or spread of variants of concerns to the country.

WHEREAS, on July 22, 2021 the Department of Health confirmed the local transmission of the highly infectious Delta variant of COVID-19 in the Philippines which is 60% more transmissible.

WHEREAS, as of 28 July 2021 the Department of Health announced 55 new cases of Delta variant bringing the total number of subject cases in the Philippines to 119 and may reach 11,000 daily new cases by the end of September if health protocols would not be properly imposed.

WHEREAS, it has been reported that there is a significant increase in the Corona Virus infections which soared to 1.15 reproduction number for the period of July 15 to 21, 2021. Said report further recommended the adoption of proactive measures to mitigate the emerging increase of cases and cautioned the public to prepare for a possible surge of the deadly virus infection.

WHEREAS, due to rising COVID-19 Delta variant cases, there is a need to create a focused group or team to handle the highly infectious Delta variant and prevent the transmission thereof.

**NOW, THEREFORE, I, JAIME R. FRESNEDI,** by virtue of the powers vested in me by law, do hereby order and decree that:

#### Section 1. Creation and Composition.

The Local Inter-Agency Task Force Against Delta Variant is hereby created and it shall be composed of the following individuals with their respective designations, namely:

#### Section 2. Functions of the Local Inter-Agency Task Force.

The Task Force shall perform the following functions, namely;

- a. Ensure that the all pertinent resolutions and issuances of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases, Department of Health and other concerned government agencies particularly on the implementation of proactive measures to slow down the surge in COVID 19 cases especially Delta variant are continually and effectively implemented.
- b. Gather data on the extent of the transmission of COVID-19 Delta and conduct research/study and recommend to the City Government of Muntinlupa possible strategies and measures to curb if not minimize the adverse effects of the virus and monitor the implementation thereof.
- c. Implement the following COVID-19 preventive measures:
  - 1. Stricter Quarantine Protocols;
  - 2. Expanded Testing;
  - 3. Contact Tracing, as well as Localized/Granular Lockdowns;
  - 4. Urgent Increase Restrictions;

- 5. Reduction of Capacity Inside Business Establishments;
- 6. Imposition of Curfew Hours;
- 7. Reduction of Mobility of Children and Adolescents;
- 8. Adherence to Minimum Public Health Standards;
- 9. Reduction of Non-Essential Travels and Social Gatherings;
- 10. Vaccination to Attain Herd Immunity;
- d. Submit to the Local Chief Executive a detailed and comprehensive report on the progress of COVID-19 Delta prevention efforts.

### Section 3. Meetings.

The Local Inter-Agency on COVID-19 Task Force Delta Variant shall meet and coordinate with the Muntinlupa Covid-19 Vaccination Task Force, duly constituted under Executive Order No. 2, s. 2021, on a regular basis, and may meet on special call, if so warranted.

The Local Inter-Agency on COVID-19 Task Force Delta Variant shall be responsible for the issuance of notices of meeting; for logistical support; for taking down of minutes and dissemination and recording thereof; and for writing, receiving, and sending correspondence.

#### Section 4. Repealing Clause.

All orders and issuances inconsistent with this order are hereby repealed or modified accordingly.

#### Section 5. Effectivity.

This order shall take effect immediately upon signing hereof, and shall remain in full force and effect until revoked, repealed or amended accordingly.
