EXECUTIVE ORDER No. 22 Series of 2021

PROVIDING FOR THE ADOPTION OF UNIFIED CURFEW HOURS AND TOTAL LIQUOR BAN DURING THE EFFECTIVITY OF ENHANCED COMMUNITY QUARANTINE (ECQ) IN THE CITY OF MUNTINLUPA

WHEREAS, on July 29 2021, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases recommended that the National Capital Region (NCR) together with other cities and municipalities be placed under Enhanced Community Quarantine (ECQ) to take effect on August 6, 2021 until August 20, 2021 to broaden the population protection against highly infectious and deadly Covid-19 Delta Variant, subject to the Omnibus Guidelines on the Implementation of Community Quarantine, as amended;

WHEREAS, under the Enhanced Community Quarantine temporary measures shall be implemented by imposing stringent limitations on movement and transportation of people, strict regulation of operating industries, provision of food and essential services, and heightened presence of uniformed personnel to enforce community quarantine protocols;

WHEREAS, the Metro Manila Council issued MMDA Resolution No. 21-16, Series of 2021, setting the standardized and unified curfew hours in the National Capital Region from 8:00 p.m. to 4:00 a.m. during the Enhanced Community Quarantine commencing on August 6, 2021 through the Metro Manila Local Government Units;

WHEREAS, as a complement to the efforts of the national government and concerned government agencies, the City Government of Muntinlupa has to adopt restrictive and regulatory measures in terms of imposition of curfew hours, liquor ban and persons allowed outside of their residence to prevent the further transmission of the deadly and infectious virus besetting the country and the people.

NOW, THEREFORE, I, JAIME R. FRESNEDI, by virtue of the powers vested in me by law, do hereby order and decree that:

SECTION 1. CURFEW HOURS.

Subject to the recommendation of the Metro Manila Council through MMDA Resolution No. 21-16, Series of 2021, the standardized and unified curfew hours from 8:00 p.m. to 4:00 a.m shall be observed in the City of Muntinlupa. However, workers, cargo vehicles, public transportation, and operating hours of permitted establishments, shall not be restricted by such curfew.

SECTION 2. LIQUOR BAN.

Pursuant to Ordinance No. 2021-216 and in order not to compromise the health and safety of the people in the City of Muntinlupa, a total ban on the sale and consumption of liquor and other alcoholic or intoxicating beverages or social drinking shall be enforced as

part of the City's tighter response effort to prevent further transmission of COVID -19 and variants of concerns during the effectivity of ECQ.

SECTION 3. ENFORCEMENT.

All concerned City Government officials and the Local Inter-Agency Task Force Against Delta Variant constituted under Executive Order No. 21, Series of 2021 are hereby enjoined to strictly enforce this directive.

SECTION 4. SEPARABILITY CLAUSE.

If for any reason(s) a provision of this Executive Order is declared invalid or unconstitutional all other provisions hereof shall remain not affected thereby shall continue to be in full force and effect.

SECTION 5. REPEALING CLAUSE.

All orders and issuances inconsistent with this order are hereby repealed or modified accordingly.

SECTION 6. EFFECTIVITY.

This order shall take effect immediately upon signing hereof, and shall remain in full force and effect until revoked, repealed or amended accordingly.
